**ORDER**

A regular bail petition has been filed on behalf of the accused petitioner namely (1) Suman Kumar Gupta @ Dhally Gupta @ Dhallu, who is in jail custody since 12.05.2026 in connection with Katihar Nagar P.S. Case No. 321/2021 for the offence registered U/S 341, 323, 308, 379, 504, 506/34 of IPC. The copy of the same has already been duly served to the Ld. Addl. P.P. for the State.

Heard the Ld. counsel for the petitioner and the learned A.P.P. for the State.

The Ld. counsel of the petitioner has submitted that and ABP no. 566/2023 has been transferred to the Court of ADJ-II, Katihar and rejected except this, no B.P. or A.B.P. on behalf of the accused petitioner has been filed or moved earlier before this court or before the Hon'ble High Court, Patna. The petitioner is quite innocent and has committed no offence and he has been falsely implicated in this case. That the petitioner has two criminal history i.e. Katihar Nagar P.S. Case No. 609/2020 and Katihar P.S. Case No. 936/2017. That the final charge-sheet against the four accused persons have been submitted. Petitioner is languishing in judicial custody since 12.05.2026. Petitioner is local man and no chance of his absconding. Petitioner is ready to furnish local and solvent bailors to the satisfaction of the court. Accordingly, prayed to grant bail.

On the other hand, the Ld. Addl. P.P. vehemently opposed the prayer of B.P. filed on behalf of the above named accused petitioner and submitted that the petitioner has committed the alleged offence under well planned manner. Hence, it is requested to reject the petition of the above named accused petitioner.

The case of the prosecution, in brief, is that on 16.06.2021 at about 08:30 PM, the informant allegedly called to Kali Temple, Naya Tola, by accused Suman Kumar Gupta @ Dhally Gupta. Upon reaching there, the accused persons allegedly surrounded him, demanded Rs. 10,000/- and on his refusal, assaulted him with lathis, sticks, belts, a knife and a dagger, causing injuries. It is further alleged that the accused snatched the informant's Vivo mobile phone, Rs. 30,000/- in cash and three gold rings before fleeing from the spot. Hence, the present case.

Heard rival submission of the Ld. counsel on behalf of the accused petitioner and the Ld. Add. P.P. for the State and perused the L.C.R. Katihar Nagar P.S. Case No. 321/2021 has been registered U/S 341, 323, 308, 379, 504, 506/34 of IPC. Petitioner is named in the FIR. The allegation against this petitioner is that at his order, co-accused assaulted the victim in which he sustained injury. However, the injury sustained by the informant is simple in nature. That the alleged recovery of the mobile phone, cash or gold rings has not been made from the conscious possession of the petitioner. Petitioner is in judicial custody since 12.05.2026. Petitioner is ready to cooperate during course of investigation and trial of this case. There is no chance of absconding or tampering with the evidence.

Hence, considering the above facts and circumstances as well as the period of custody, I find it judicious to enlarge the above named accused petitioner on bail on furnishing bail bond of Rs. 10,000/- (Rupees Ten Thousand only) with two sureties of like amount each to the satisfaction of the Ld. Trial Court.
