Title Suit No. 17 of 2007

10.04.2026: Vide order dated 19.11.2025, this Court was pleased to amalgamate the records of Title Suit No. 17 of 2007 and Title Suit No. 66 of 2013, as both the suits relate to the same suit land and involve substantially the same parties and issues.

2. After such amalgamation, it has been noticed that a difficulty has arisen regarding the proper representation and designation of the parties in the consolidated proceeding. For the sake of clarity, convenience, and proper adjudication, it has become necessary to determine the status and array of the parties in the amalgamated record.

3. It is, therefore, ordered that the amalgamated proceeding shall continue under the heading of Title Suit No. 17 of 2007. The plaintiff Balmiki Paswan of Title Suit No. 17 of 2007 shall remain as the plaintiff in the amalgamated suit. The plaintiff Manju Devi of Title Suit No. 66 of 2013 shall be transposed as Defendant No. 1, and the plaint filed therein shall be treated as a counter-claim in the present proceeding.

4. Further, the defendants of Title Suit No. 17 of 2007 shall be re-numbered and arrayed as Defendant Nos. 2 to 11 in the following manner: Babita Sinha (Defendant No. 3 in TS No. 66/2013) as Defendant No. 2; Mukesh Chaudhary (Defendant No. 4 in TS No. 66/2013) as Defendant No.

3; Ranju Devi (Defendant No. 6 in TS No. 66/2013) as Defendant No. 4; Chhittan Paswan as Defendant No. 5; Anu Sinha (Defendant No. 5 in TS No. 66/2013) as Defendant No. 6; Kamli Devi (Defendant No. 2 in TS No. 66/2013) as Defendant No. 7; Sunaina Devi as Defendant No. 8; Karuna Devi as Defendant No. 9; Rina Devi as Defendant No. 10; and Chandrawati Devi (Defendant No. 1 in TS No. 66/2013) as Defendant No. 11.

5. It is further ordered that the defendants of Title Suit No. 66 of 2013, namely Krishnandan Paswan (Defendant No. 2), Ritesh Drolliya (Defendant No. 4), Babita Devi (Defendant No. 9), Jhilli Devi (Defendant No. 10), Bina Sinha (Defendant No. 11), Nupur Verma (Defendant No. 13), and Pinki Sinha (Defendant No. 14), shall be arrayed in the amalgamated suit as Defendant Nos. 11, 12, 13, 14, 15, 16, 17, and 18 respectively, subject to necessary correction in numbering to avoid duplication.

6. The office is directed to prepare a consolidated cause title in terms of this order, carry out necessary corrections in the records, and ensure that all future proceedings reflect the revised array of parties.

7. All parties are hereby directed to represent themselves in accordance with the revised cause title and their respective status as determined by this order.

8. Put up on dated 20.04.2026 for further orders in terms of trial.
