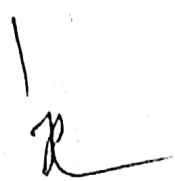

that all the necessary parties must be impleaded in the suit. The issues under this suit could be answered effectively and properly, if all the parties having even a slight interest in the suit - property is present on the record. Hence, the petition dt. ^v28/05/2025 (28/05/2025) is hereby allowed on the cost of Rs. One thousand (01,000/-) only to be given in the hands of defendants. Office is thereafter directed to substitute the legal heirs of deceased defendant no. 1 Desh Bikul @ Bikul Paswan in the plaint as per the details provided by plaintiff in their substitution petition dt. 17/10/2024.

The plaintiffs are hereby further directed to take immediate steps for the appearance of the added/substituted defendants.

Put up on 05/06/2025 for substitution and for taking steps for appearance of substituted defendants.
