ORDER

This regular bail petition has been filed under section 483 B.N.S.S. on behalf of the petitioner namely **Ikhtiyar Ahmad**, who is under custody since 26.12.2025 in connection with **Jhanjharpur P.S Case No. 109/2025 U/s- 103(1), 3(5) of B.N.S** which is pending in the court of A.C.J.M-I, Jhanjharpur is being pressed and heard.

The prosecution case in brief is that informant's Matlub Ahmad, younger brother namely Safar Ali was the driver of truck. On 01.04.2025, on pressuring to go on duty by the owner of truck namely Sagir Ahmad @ Kale, he was sent to Assam with another driver Mansoor Ali @ Banti, with truck no. UP22BT4021. When truck was returning on 15.04.2025, on NH27 near north of Kamla river bridge, Jhanjharpur, with the intention to kill, Mansoor Ali @ Banti attacked on victim Safar Ali with the iron rod that caused head injury. The deceased fell down, and then petitioner accused attacked with iron rod that caused fracture of victim's hand, and leg. Then tried to crush him, and drove over him. Then, petitioner accused made a call to Sagir Ahmad @ Kale Ikhtiyar, and Imtiyaj Ali, and told that he had finished Safar Ali. That conversation listen by the deceased. Informant elder brother Md. Nuri came to Jhanjharpur, and victim referred to Darbhanga on 16.04.2025, where doctor referred to Delhi on 17.04.2025. During way to Delhi, he died. Hence, this case.

Learned counsel for the accused petitioner submits that the accused petitioner is innocent, and has not committed any offence. He has no criminal

antecedent. That no any regular or anticipatory bail petition has been filed on behalf of the petitioner before your Hon'ble Court, or Hon'ble Patna High Court, Patna. The petitioner has falsely been implicated in this case out of previous grudge, malice, spite, and also due to local dirty village party politics. That the petitioner was not involved in this occurrence. That the petitioner is under judicial custody since 26.12.2025, and sufficiently been punished. Accordingly, it has been prayed to grant bail to the accused petitioner.

The learned Add. PP opposed the prayer for bail.

Heard the argument and perused the case diary. Witnesses in para-2 and 19 of case diary, had supported the occurrence. Even from tower location of mobile of petitioner, which is endorsed in case diary, it is apparent that the petitioner was in touch with co accused. Postmortem report in para-92 of case diary shows cause of death due to shock and hemorrhage, as a result of ante mortem injuries. Prima facie it appears that murder has been committed in conspiracy, in guise of road accident. Investigation is still going on.

Considering the aforesaid facts, the regular bail petition of the petitioner namely **Ikhtiyar Ahmad** is hereby **rejected**.
