This anticipatory bail petition has been filed on behalf of accused namely Pappu Kumar Mandal, seeking pre-arrest bail, in connection with Ghoghardiha P.S Case No- 39/2026, U/s- 69, 89, 351(2), 3(5) of the BNS 2. Heard Smt. Ranjeeta Kumari, Ld. Advocate on behalf of petitioner and Sri Indrakant Prasad, learned APP for the state. 3. Ld. counsel of the petitioner Smt. Ranjeeta Kumari has submitted that the no bail petition either regular or anticipatory has been filed earlier either before this Ld. Court or before Hon'ble High Court, Patna and petitioner has no criminal antecedent. It is further submitted that petitioner is innocent and has not committed any offence and the petitioner is involved in this case only to make pressure to marry the informant. It is also submitted that neither section 69 nor section 89 of BNS is made out against the petitioner and the case is only an instrument to make pressure to agree for marriage and blackmail. Lastly, it is submitted that petitioner is apprehending his arrest, Ld. Counsel prayed to enlarge the petitioner on anticipatory bail. 4. The learned APP Sri Indrakant Prasad opposed the petition and prayed to reject it. 5. The prosecution case in brief is that the informant of this case has alleged that Pappu Kumar Mandal has sexually exploited her by pretext of marriage and ultimately he denied to marry and when informant approached to Pappu Kumar Mandal's family and requested for marriage, then all the accused persons demanded Rs. 5 lacs rupee, household articles and Bullet

Contd... 05.05.2026	Motorcycle. Hence, this case. 6. Heard both side at the length and perused the case record along with case diary available. From perusal of the record it transpires that on the basis of application given by the informant victim before SHO Ghoghardiha this very case has been registered against the petitioner and others U/s- 69, 89, 351(2), 3(5) of the BNS. From perusal it also transpires that petitioner is named prime accused of the case who has sexually exploited to the informant victim by pretext of marriage and ultimately he denied to marry with her. From perusal of the case diary it transpires that the witnesses in para No. 2, 6 & 7 have supported the case of the prosecution. Apart from that victim herself has supported the case of the prosecution in her statement, recorded U/s 183 of the BNSS in para No. 39 of the case diary and the investigation is still going on. 7. Therefore, considering the aforesaid facts and discussions made above as well as gravity and nature of offence, I am not inclined to enlarge the petitioner Pappu Kumar Mandal on anticipatory bail, accordingly, prayer for anticipatory bail on behalf of aforesaid petitioner is hereby rejected.
