Heard Sri Bechan Ray, learned counsel for the petitioner and Sri D.S. Jha learned APP for the state.</li> <li>3. The learned counsel of the petitioner has submitted that no any sort of bail petition has earlier been filed on behalf of this petitioner before this court, or any superior court. It has further been submitted that the petitioners are quite innocent, have committed no offence and has falsely been implicated in this case. It has further been submitted that the petitioner has been made accused on the basis of confessional statement of co-accused Rahul Kumar which is not admissible in law. It has further been submitted that the petitioner has been neither arrested on spot nor anything incriminating or stolen article has been recovered from his conscious possession or premises. It has further submitted that petitioner has three criminal history. He has further submitted that the petitioner is in judicial custody since 10.03.2026. It has further been submitted that the petitioner is a local man and he is ready to furnish the satisfactory bailors, if he be enlarged on bail. The learned counsel prays to allow the petition.</li> <li>4. The learned APP opposed the bail petition and prayed to reject it.</li> <li>5. The prosecution case in short is that on 25.08.2025 at about 11.45 Am in course of coming home from the house of his Mausi when informant reached near village Kishanpatti Bhutahi Balan bridge 4-5 persons came there from back side on motorcycles and one of them snatched his Samsung mobile and fled away.</li> <li>6.
