Regular bail petition has been filed on behalf of the accused in custody namely Rahul Kumar aged about 22 years S/o- Kamlesh Yadav, R/o-Village- Bishanpur, PS.- Phulparas ,District Madhubani, in connection with Phulparas P.S Case No- 130/2026 Gr.No.-646/2026, U/s- 25(1-B),26,35 of Arms Act. 2. Heard Sri Nageshwar Yadav, learned counsel for the petitioner and Sri Deo Shankar Jha learned APP for the state. 3. The learned counsel of the petitioner has submitted that no other regular bail petition has been filed earlier on behalf of the petitioner. It has further been submitted that the petitioner is quite innocent, has committed no offence and has falsely been implicated in this case. It has further stated that petitioner has two criminal antecedent. It has further submitted that the petitioner is in judicial custody since 28.03.2026. It has further been submitted that nothing incriminating has been recovered from the possession of the petitioner. It has further been submitted that the petitioner is a local man and he is ready to furnish the satisfactory bailors, if he be enlarged on bail. The learned counsel prays to allow the petition. 4. The learned APP opposed the bail petition and prayed to reject it. 5. The prosecution case in short is that on 27.03.2026 one countrymade pistol was recovered from the possession of the petitioner and other accused. 6. Perused the case record, case diary, submissions of both the parties and other materials available on record and found that one country made pistol was recovered from the possession of the petitioner. Further the petitioner is in custody since 28.03.2026 and police have submitted charge sheet. 7. In the facts and circumstances mentioned above and keeping in view the period of custody, the petitioner Rahul Kumar is directed to be released on bail on furnishing bail bonds of Rs. 10000/- with two sureties of like amount, with an undertaking under section 437 (3) Cr.P.C, to the satisfaction of the learned
