This regular bail petition has been filed on behalf of accused namely Rama Shankar Prasad @ Shankar Kumar, who is under custody since 23.04.2026, in connection with Laukaha P.S Case No- 158/2022, U/s- 341, 323, 324, 307, 379, 504, 34 of the IPC. 2. Heard Sri Bal Ram Yadav, Ld. Advocate on behalf of petitioner and Sri Indrakant Prasad, learned APP for the state. 3. Ld. counsel of the petitioner Sri Bal Ram Yadav has submitted that no other bail petition has earlier been filed either before this Court or before Hon'ble High Court, Patna and petitioner has no criminal antecedent. It is further submitted that petitioner is quite innocent and has not committed any offence and no occurrence as alleged has taken place and from perusal of the FIR no case is made out against the petitioner. It is also submitted that prosecution story is false, fabricated, baseless and concocted and petitioner has falsely been implicated in this false case due to malice, spite, personal grudge and dirty village party politics and pattidari land dispute and alleged all sections are bailable except U/s 307 & 379 of the IPC, which are added only to make the case graver and petitioner is student of B.ed. 2nd Year and final examination will be held in June, 2026. Lastly, it is submitted that petitioner is under custody since 23.04.2026, Ld. Counsel prayed to enlarge the petitioner on bail. 4. The learned APP Sri Indrakant Prasad opposed the petition and prayed

He has alleged in his fardbyan that on 20.06.2022 at about 08:00 PM, all the accused persons named in FIR including this petitioner and 10 unknown persons caught him by using abusive language and assaulted by means of fist and slaps and on order of Suresh Kumar, Suman Kumar assaulted over his head by means of dagger/knife with intention to kill, resulted he became injured and fell on the ground and became unconscious and Suman Kumar snatched Rs. 5000/- from his pocket. Hence, this case. 6. Heard both sides at length and perused the case record along with LCR including case diary and injury report. From perusal of the record it transpires that on the basis of the fardbyan made by the informant before Laukaha P.S., this very case has been registered U/s- 341, 323, 324, 307, 379, 504, 34 of the IPC against the petitioner and others. As per allegation it is alleged in the FIR that the petitioner accused has assaulted to the informant victim by means of knife, resulted he sustained injuries and become unconscious and fell on the ground. From perusal of the record it also transpires that petitioner is behind the bar since 23.04.2026 and informant's injuries found simple in nature. Apart from that there is case and counter case in between the parties. 7. Therefore, considering the aforesaid facts and discussions made above, I am inclined to enlarge the petitioner, namely Rama Shankar Prasad @

Court below with following conditions;- I. That petitioner will co-operate in investigation and he make himself available whenever it is required by the investigating officer till submission of charge sheet if not chargesheeted. II. That the petitioner will attend the Court as per the bond conditions and petitioner will not commit the similar offence or offences in future. III. That the petitioner will not threaten, induce or promise any person acquainted with the facts of the case to prevent them from disclosing information. IV. An undertaking to follow the conditions as above be given on behalf of petitioner accused along with bail bond, in case of violation and breach of the conditions, the prosecution will be at liberty to move for cancellation of their bail bond.
