	12.05.2026	1. This anticipatory bail petition has been filed on behalf of accused namely 1. Suman Kumar@ Suman Sarkar, 2. Suresh Kumar, 3. Sachidanand Kumar, seeking pre-arrest bail, in connection with Laukaha P.S Case No- 158/2022, U/s- 341, 323, 324, 307, 379, 504, 34 of the IPC. 2. Heard Sri Bal Ram Yadav, Ld. Advocate on behalf of petitioners and Sri Indrakant Prasad, learned APP for the state. 3. Ld. counsel of the petitioners Sri Bal Ram Yadav has submitted that no other bail petition has earlier been filed either before this Court or before Hon'ble High Court, Patna and petitioners have no criminal antecedent. It is further submitted that petitioners are quite innocent and have not committed any offence and no occurrence as alleged has taken place and from perusal of the FIR no case is made out against the petitioners. It is also submitted that prosecution story is false, fabricated, baseless and concocted and petitioners have falsely been implicated in this false case due to malice, spite, personal grudge and dirty village party politics and alleged all sections are bailable except U/s 307 & 379 of the IPC, which are added only to make the case graver and this case is counter blast of Laukaha P.S. Case No. 160/22. Lastly, it is submitted that petitioners are apprehending their arrest, Ld. Counsel prayed to enlarge the petitioners on anticipatory bail. 4. The learned APP Sri Indrakant Prasad opposed the petition and prayed

He has alleged in his fardbyan that on 20.06.2022 at about 08:00 PM, all the accused persons named in FIR including these petitioners and 10 unknown persons caught him by using abusive language and assaulted by means of fist and slaps and on order of Suresh Kumar, Suman Kumar assaulted over his head by means of dagger/knife with intention to kill, resulted he became injured and fell on the ground and became unconscious and Suman Kumar snatched Rs. 5000/- from his pocket. Hence, this case. 6. Heard both sides at length and perused the case record along with LCR including case diary and injury report. From perusal of the record it transpires that on the basis of the fardbyan made by the informant before Laukaha P.S., this very case has been registered U/s- 341, 323, 324, 307, 379, 504, 34 of the IPC against the petitioner and others. As per allegation petitioner accused No. 01 has assaulted to the informant victim in order to obey the order of the petitioner accused No.02 by means of dagger/knife, resulted victim informant sustained injuries on vital part of the body such as head. There is direct allegation against the petitioners in the FIR to assault the informant and there is sufficient material available against the petitioners in the case diary. 7. Therefore, considering the facts discussed above, gravity and nature of offence, I am not inclined to enlarge the petitioners on anticipatory bail
