Subham Kumar Thakur aged about 26 years S/o- Jayanand Thakur resident of Vill.- Belmohan, P.S- Phulparas, Dist-Madhubani in connction with Phulparas P.S case No- 51/2026 Gr.No.-282/2026,U/s- 64(1),61,351(2) of BNS.</li> <li>2. Heard Sri Sharat Chandra Yadav for the petitioner and Sri Deo Shankar Jha, learned APP for the state.</li> <li>3. The learned counsel of the petitioner submitted that no any sort of bail petition has earlier been filed in this court or any higher court. It was further submitted that the petitioner is quite innocent, has not committed any offence and falsely been implicated in this case. He has further submitted that petitioner has no criminal antecedent. It has further stated that informant wants to marry with the petitioner one sided but the petitioner refused the proposal and for this reason informant filed this false case against the petitioner to put pressure. It was also submitted that the petitioner is local man and there is no chance of his absconding, if he be enlarged on bail. The learned counsel prayed to allow the petitioner on bail.</li> <li>4. The learned APP opposed the petition and prayed to reject it.</li> <li>5. The prosecution case in short is that on 06.02.2026 at about 03:15 PM the accused petitioner namely Subham Kumar Thakur committed rape at the instance of pistol.</li> <li>6. Perused the case record. From perusal of the case record, case diary , submissions of both the parties and other materials available on record, I find that there is allegation against the petitioner to commit rape of informant at the instance of pistol. The prosecution witnesses have supported the prosecution case in para 14,15,16,17,18,19 of case diary and investigation is going on. In para 36 victim has supported the allegation of rape recorded U/s -183 of BNSS.</li> </ol> |                                 |
