This regular bail petition has been filed on behalf of accused namely Ravin Yadav @ Ravindra Yadav, who is under custody since 18.05.2026, in connection with Andhramath P.S Case No- 113/2025, U/s-127(2), 115(2), 117(2), 64(1) of the BNS. 2. Heard Sri Rohit Anand, Ld. Advocate on behalf of petitioner and Sri Indrakant Prasad, learned APP for the state. 3. Ld. counsel of the petitioner Sri Rohit Anand has submitted that earlier ABP No. 207 /2026 was filed on behalf of this petitioner, which was rejected by this Court besides that no other bail petition either before this Court of before Hon'ble High Court has been filed and petitioner has no any criminal antecedent. It is further submitted that petitioner is quite innocent and has not committed any offence and no occurrence has taken place as alleged in the FIR and this case has been filed by the informant due to ulterior motive with intention to harass the petitioner and prosecution story is totally false and fabricated. It is also submitted that this case has been compromised in between the parties and no case is made out U/s 64 (1) of the BNS. Lastly, it is submitted that petitioner is under custody since 18.05.2026, Ld. Counsel prayed to enlarge the petitioner on bail. 4. The learned APP Sri Indrakant Prasad opposed the petition and prayed to reject it. 5. The prosecution case in short is that the informant of this case has alleged

Contd... 16.06.2026	that on 24.06.2025 at 01:20 AM, accused Ravin Yadav entered into the house of the informant by breaking bamboo boundary and committed rape with her and also assaulted her with fists and slaps and threatened her for dire consequence. Hence, this case. 6. Heard both sides at length and perused the case record along with case diary available. From perusal of the record it transpires that, on the basis of written application submitted by the informant victim before SHO Andhramath, this very case has been registered U/s-127(2), 115(2), 117(2), 64(1) of the BNS, against the petitioner. From perusal of the FIR it is alleged that on the date and time of occurrence as alleged in the FIR, accused person entered into the house of the informant by breaking bamboo boundary and committed rape with her and and also assaulted her with fists and slaps but from perusal it also transpires that informant victim has compromised this case with the petitioner accused without any fear of pressure and a joint compromise petition bearing signature of both the parties dully verified by their advocates is also annexed with the bail petition. Inspite of that the victim informant also present before the court and conceded the content of the compromise and it is prominent to mention here that as per medical report of the victim, mentioned in para No. 108 of the case diary, no medical evidence of sexual assault is found. From perusal it also transpires that petitioner is still behind the bar since 18.05.2026 and as per para No. 190 of the case diary, petitioner has got clean antecedent having no any criminal antecedent.
