**O R D E R**

**Dated: 07.07.2026**

This regular bail petition has been filed under section 483 B.N.S.S. on behalf of the petitioner **Adarsh Kumar Jha** who has been arrested in connection with **Bhairavsthan PS Case No.81/2026, GR No.1064/2026 under section 25(1-b)a, 26/35 Arms Act.,** which is pending in the court of A.C.J.M. 1<sup>st</sup>, Jhanjharpur, is being pressed and heard.

The prosecution case in brief on the basis of typed application of Basant Kumar, S.I. is that on 19.05.2026 at about 10:05 AM, the informant along with others police constables were on duty on NH 27. In the meantime at about 14:15 PM, informant received a confidential information that some arms are being sold and purchased at village Raiyam, near Monisair Pokhar. The informant informed to senior officer, and reached at village Raiyam Manisair Pokhar, where two persons started fleeing on seeing police. Police personnel chased, and caught them. Then these persons disclosed their name as Madhav Kumar Jha, and Adarsh Kumar Jha. On search of Madhav Kumar Jha found a mobile, and a country made katta. From petitioner mobile was seized. Seizure list was prepared in presence of two independent witnesses. On demand of paper regarding arms, no any paper produced by the accused. Hence, this case.

Learned Counsel of the petitioner accused has submitted that no any bail petition has been filed earlier in any Court, or in Hon'ble Patna High Court, Patna. It is further submitted that the petitioner accused is quite innocent, and has not committed any offense. No occurrence as alleged has taken place. The prosecution story is totally false, absurd, and concocted. The petitioner has been implicated in this false case out of previous grudge, malice, spite, and also due to local dirty village party politics. Nothing has been recovered from the possession of the petitioner. The petitioner is villager of co-accused Madhav Kumar Jha, but has no knowledge regarding the activity of co-accused Madhav Kumar Jha. The petitioner is bachelor of commerce student of Bahera College, Darbhanga. The petitioner is in judicial custody since 20.05.2026. Accordingly, it has been prayed to grant bail to the accused petitioner.

The learned APP had opposed the prayer for bail.

Heard both sides at length, and perused the case diary. From case diary it is apparent that petitioner has no criminal antecedent. Fire arms was seized from co accused. Investigation has almost completed. Petitioner is in custody since 20.05.26, which is about two months. From the documents submitted on behalf of petitioner, it appears that petitioner is a student of Bachelor of commerce. Considering the fact that petitioner has no criminal antecedent, and is a student, the bail petition of petitioner namely **Adarsh Kumar Jha** is **allowed**. He is directed to be released on furnishing bail bond of Rs.10,000/- with two sureties of like amount each to the satisfaction of Ld. Court concerned.
