27.01.2025	Record put up before the Court for taking cognizance. Mr. Divyansh Pandey, Learned A.P.O. appeared on behalf of State of Bihar for hearing on point of cognizance, perused the case record. From perusal of case record it transpires that this case was instituted for the offences punishable under section 323, 341, 354, 379, 427, 447, 504, 506/34 of Indian Penal Code against (1) Md. Murtuja, (2) Sabra Khatoon, (3) Md. Raudi Manduri. After investigation the Investigating Officer has submitted chargesheet vide Chargesheet No. 05/2024, Dated- 20.01.2024 on 01.02.2024 for the offences punishable under section 323, 341, 427, 504, 506 of Indian Penal Code against (1) Sabrah Khatoon. Investigating Officer has not sent up accused namely (1) Md. Murtuja Mansuri, (2) Md. Raudi Manduri. From perusal of F.I.R, Chargesheet and Case diary, this court finds that non sent up accused are named accused of FIR and there is direct and specific allegation against them. Informant in FIR and her Re-Statement vide para 09 of case diary and prosecution witnesses vide para 10, 11, 12 of case diary have supported active involvement of non sent up accused in alleged offence. Hence active involvement of non sent up accused can't be ruled out at this juncture. This court finds sufficient materials available on record to proceed further against the accused persons whose names have been mentioned in column (07) of the FIR. Accordingly cognizance of the offences punishable under section 323, 341, 427, 504, 506 of Indian Penal Code is taken against accused persons namely (1) Md. Murtuja, (2) Sabra Khatoon, (3) Md. Raudi Manduri. Office Clerk is directed to upload this order on CIS and update the CIS accordingly. Office clerk is directed to summon the accused at once. Put up the case record on 11.04.2025 for appearance. (Md Shuaib) Judicial Magistrate First Class Benipatti, Sub-Divisional Court, Benipatti, District- Madhubani.
