Mr. Kamlesh Chaturvedi, Learned S.D.P.O appeared on behalf of State of Bihar for hearing on point of cognizance. Heard Learned S.D.P.O on point of cognizance in length and perused the case record. From perusal of case record it transpires that this case was instituted for the offences punishable under section 147, 149, 323, 341, 354-B, 379, 504, 506 of Indian Penal Code against (1) Sanjeet Raut, (2) Arti Kumari, (3) Sachin Raut, (4) Rajesh Raut, (5) Ramesh Raut, (6) Indrajeet Raut, (7) Phuleshwar Raut.</p> <p style="text-align: center;">After investigation the Investigating Officer has submitted chargesheet vide Chargesheet No. 07/2025, Dated- 12.01.2025 on 24.02.2025 for the offences punishable under section 147, 149, 323, 341, 504, 506/34 of Indian Penal Code against (1) Sanjeet Raut, (2) Arti Kumari, (3) Sachin Kumar Raut, (4) Rajesh Raut, (5) Ramesh Prasad Raut, (6) Indrajeet Kumar Raut, (7) Phuleshwar Raut.</p> <p style="text-align: center;">From perusal of F.I.R, Chargesheet and Case diary, this court finds sufficient materials available on record to proceed further against the accused persons whose names have been mentioned in column (11) of the Chargesheet. Since Section 149 and 34 of Indian Penal Code can not be applied on one occurrence at same time. Accordingly cognizance of the offences punishable under section 323, 341, 504, 506/34 of Indian Penal Code is taken against accused persons namely (1) Sanjeet Raut, (2) Arti Kumari, (3) Sachin Kumar Raut, (4) Rajesh Raut, (5) Ramesh Prasad Raut, (6) Indrajeet Kumar Raut, (7) Phuleshwar Raut.</p> <p>Office Clerk is directed to upload this order on CIS and update the CIS accordingly.
