04.03.2025	<p>Record put up before the Court for taking cognizance. Mr. Kamlesh Chaturvedi, Learned S.D.P.O appeared on behalf of State of Bihar for hearing on point of cognizance. Heard Learned S.D.P.O on point of cognizance in length and perused the case record. From perusal of case record it transpires that this case was instituted for the offences punishable under section 379 of Indian Penal Code against unknown accused.</p> <p>After investigation the Investigating Officer has submitted chargesheet vide Chargesheet No. 185/2024, Dated- 20.12.2024 on 04.03.2025 for the offences punishable under section 379, 461 of Indian Penal Code against (1) Md Saddam Raiyeen, (2) Md. Rubiya Fakir @ Arshad. Investigating Officer has mentioned that investigation is still going on against (1) Md. Azam.</p> <p>From perusal of F.I.R, Chargesheet and Case diary, this court finds sufficient materials available on record to proceed further against the accused persons whose names have been mentioned in column (11) of the Chargesheet. Accordingly cognizance of the offences punishable under section 379, 461 of Indian Penal Code against accused persons namely (1) Md. Saddam Raiyeen, (2) Md. Rubiya Fakir @ Arshad.</p> <p>Office Clerk is further directed to open a separate record as investigation is still going on against (1) Md. Azam. Office Clerk is also directed to upload this order on CIS and update the CIS accordingly. Since accused Rubiya Fakir @ Arshad is in Judicial Custody hence Office Clerk is directed to serve copy of Police Paper to accused Rubiya Fakir @ Arshad through Jail Authority and Jail Authority is directed to serve the copy of Police Paper to Rubiya Fakir @ Arshad and send service report to this court in the earliest.</p> <p>Office Clerk is also directed to summon Md. Saddam Raiyeen at once.
