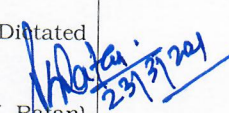

Hence, considering the entire materials available on the record, it is accordingly----- <u>ORDERED</u> 1) That the <u>cognizance</u> of offence punishable u/Ss.:- 341, 323, 324, 504, 34 of IPC is hereby taken against all the above named accused persons viz. 1. Awdhesh Pandey, 2. Raja Pandey @ Mrityunjay Pandey, 3. Gunja Pandey @ Gunjan Pandey, 4. Manoj Thakur & 5.
