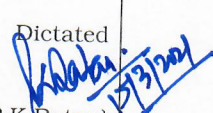

S.D.P.O. on the point of cognizance on behalf of the State and perused this case record. It appears from the perusal that the Investigation Officer has filed the Charge-Sheet bearing its No.:- 68/2020; dated: - 28-02-2021. <u>FINDINGS</u> This court has now perused the FIR, the Charge-Sheet along with the entire Case Diary as well as the materials available on the record. The re-statement of informant contained in Para- 07 of the Case Diary, the statements of witnesses contained in Paras- 08, 09, 60 of the Case Diary as well as Injury Report mentioned in Para- 30, 39, 48 and all other materials available with record at present strongly suggests the commission of offences punishable, u/Ss:- 341, 323, 324, 325, 427, 504, 506, 34 of IPC and the complicity of all the accused persons viz.: 1. Sandeep Jha, S/O- Nasib Jha, 2. Meena Jha, W/O- Sandeep Jha, 3. Rajneet Kashyap @ Raushan, 4. Rajneesh Kashyap @ Chhotu, both S/O- Sandeep Jha, 5. Manish Bhardwaj & 6. Aashish Bhardwaj, both S/O- Vikas Jha, all R/O Vill.- Dulha, P.S.- Bisfi, District- Madhubani, in the commission of the aforesaid alleged crime. Hence, considering the entire materials available on the record, it is accordingly----- <u>ORDERED</u> 1) That the cognizance of offence punishable u/Ss:- 341, 323, 324, 325, 427, 504, 506, 34 of IPC is hereby taken against all the accused persons namely, 1. Sandeep Jha, 2. Meena Jha, 3. Rajneet Kashyap @ Raushan, 4. Rajneesh Kashyap @ Chhotu, 5. Manish Bhardwaj & 6. Aashish Bhardwaj and hence, they are accordingly, hereby put on trial. 2) That this record is kept in Personal File for trial in accordance with law. 3) That the Office Clerk is directed to get this record registered in the Trial Register. 4) That the Office Clerk is further directed to issue summon against the aforesaid accused for their appearance in this Court forthwith after the due verification.
