Mr. Kamlesh Chaturvedi, Learned S.D.P.O turned up on behalf of State of Bihar for hearing on point of cognizance, perused the case record. From perusal of case record it transpires that this case was instituted for the offences punishable under section 143, 323, 341, 342, 354-B, 379, 504, 506 of Indian Penal Code against (1) Baidnath Das, (2) Rishikesh Kumar Das, (3) Sunita Devi, (4) Soni Kumari, (5) Pyarelal Das, (6) Amar Das, (7) Ankit Das, (8) Anita Devi.</p> <p style="text-align: center;">After investigation the Investigating Officer has submitted chargesheet vide Chargesheet No. 110/2024, Dated- 06.07.2024 on 30.08.2024 for the offences punishable under section 323, 341, 342, 354, 504, 506 of Indian Penal Code against (1) Sunita Devi, (2) Baidnath Das. Investigating Officer has not sent up accused namely (1) Rishikesh Kumar, (2) Soni Kumari, (3) Pyarelal Das, (4) Amar Das, (5) Ankit Das, (6) Anita Devi.</p> <p style="text-align: center;">From perusal of F.I.R, Chargesheet and Case diary, this court finds that non sent up accused are named accused of FIR and there is direct and specific allegation against them. Informant in FIR and prosecution witnesses vide para 08, 09 of case diary have supported active involvement of non sent up accused in alleged offence. Hence active involvement of non sent up accused can't be ruled out at this juncture. This court finds sufficient materials available on record to proceed further against the accused persons whose names have been mentioned in column (07) of the FIR. Accordingly cognizance of the offences punishable under section 323, 341, 342, 354, 504, 506 of Indian Penal Code is taken against accused persons namely (1) Baidnath Das, (2) Rishikesh Kumar Das, (3) Sunita Devi, (4) Soni Kumari, (5) Pyarelal Das, (6) Amar Das, (7) Ankit Das, (8) Anita Devi.</p> <p>Office Clerk is directed to upload this order on CIS and update the CIS accordingly. Office clerk is directed to summon the accused at once.
