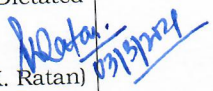

It appears from the perusal that the Investigation Officer has filed the Charge-Sheet bearing its No.- 08/2020; dated: - 21-01-2020 against all the accused persons viz., 1. Asharfi Sahni, 2. Rambachan Sahni, both S/O- Late Sutie Sahni & 3. Ram Narayan Sahni, S/O- Laldhari Sahni, all R/O Vill.- Dhanushi, P.S.- Benipatti, District- Madhubani, u/Ss.- 341, 323, 354B, 379, 34 of IPC. <u>FINDINGS</u> This court has perused the FIR, the Charge-Sheet along with the entire Case Diary and the materials available on the record. The materials available on the record prima facie shows the complicity of all the accused persons viz., 1. Asharfi Sahni, 2. Rambachan Sahni & 3. Ram Narayan Sahni, in the commission of the alleged crime who have also been named in the Column-11(i) of the Formal Charge Sheet. Hence, considering the entire materials available on the record, it is accordingly----- <u>ORDERED</u> 1) That the cognizance of offence punishable u/Ss.- 341, 323, 354B, 379, 34 of IPC is hereby taken against the above named accused persons viz. 1. Asharfi Sahni, 2. Rambachan Sahni & 3. Ram Narayan Sahni and hence, they are accordingly, hereby put on trial. 2) That this record is kept in Personal File for trial in accordance with law. 3) That the Office Clerk is directed to get this record registered in the Trial Register. 4) That the Office Clerk is further directed to issue summon against the aforesaid accused for their appearance in this Court forthwith after the due verification.
