13.11.2024	Record put up before the Court for taking cognizance. No one turned up on behalf of State of Bihar for hearing on point of cognizance, perused the case record. From perusal of case record it transpires that this case was instituted for the offences punishable under section 323, 341, 354 (A), 379, 448, 504, 506/34 of Indian Penal Code against (1) Yogendra Mandal, (2) Amit Mandal, (3) Jitendra Mandal, (4) Pramod Mandal, (5) Ramsundar Mandal, (6) Vinod Mandal, (7) Anita Devi, (8) Shanti Devi, (9) Ranju Devi, (10) Phulo Devi, (11) Sachin Kumar. After investigation the Investigating Officer has submitted chargesheet vide Chargesheet No. 04/2024, Dated- 15.01.2024 on 30.01.2024 for the offences punishable under section 323, 341, 504, 506/34 of Indian Penal Code against (1) Yogendra Mandal, (2) Ramsundar Mandal, (3) Anita Devi, (4) Phulo Devi. Investigating Officer has not sent up accused namely (5) Amit Kumar, (6) Jitendra Mandal, (7) Sachin Mandal, (8) Vinod Mandal, (9) Pramod Mandal, (10) Shanti Devi, (11) Ranju Devi. From perusal of F.I.R, Chargesheet and Case diary, this court finds sufficient materials available on record to proceed further against the accused persons whose names have been mentioned in column (11) of the Chargesheet. Accordingly cognizance of the offences punishable under section 323, 341, 504, 506/34 of Indian Penal Code is taken against accused persons namely (1) Yogendra Mandal, (2) Ramsundar Mandal, (3) Anita Devi, (4) Phulo Devi. Office Clerk is directed to upload this order on CIS and update the CIS accordingly. Office clerk is directed to summon the accused at once.
