21.07.2025	Record put up before the Court for taking cognizance. Mr. Kamlesh Chaturvedi, Learned S.D.P.O turned up on behalf of State of Bihar for hearing on point of cognizance, perused the case record. From perusal of case record it transpires that this case was instituted for the offences punishable under Section 307, 323, 341, 354(B), 379, 504, 506/34 of Indian Penal Code against (1) Rampujan Sah, (2) Indradev Sah, (3) Bhulla Sah, (4) Amar Kumar Sah, (5) Satish Sah, (6) Panchi Kumari. After investigation the Investigating Officer has submitted chargesheet vide Chargesheet No. 242/2022, Dated- 30.11.2022 on 06.12.2022 for the offences punishable under Section 323, 324, 341, 504, 506 of Indian Penal Code against (1) Rampujan Sah, (2) Indradev Sah. Investigating Officer has not sent up accused namely (1) Panchi Kumari, (2) Satish Kumar Sah, (3) Amardev Kumar Sah, (4) Suryadev Sah @ Bhulla Sah. From perusal of F.I.R, Chargesheet and Case diary, this court finds that non sent up accused are named accused of FIR and there is direct and specific allegation against them in the FIR. Informant in her Re-Statement vide para 02 of case diary and prosecution witnesses vide para 07, 08, 09 of case diary have supported active involvement of non sent up accused in alleged offence. Hence their active involvement can't be ruled out at this juncture. This Court found sufficient material available on record against all accused whose names have been mentioned in coulumn (07) of FIR. Accordingly cognizance of the offences punishable under Section 307, 323, 324, 341, 504, 506 of Indian Penal Code is taken against accused persons namely (1) Rampujan Sah, (2) Indradev Sah, (3) Suryadev Sah @ Bhulla Sah, (4) Amar Kumar Sah @ Amardev Kumar Sah, (5) Satish Sah, (6) Panchi Kumari.
