Bail Application

In J.J.B. Case No. 18/2021(Suppl. Kharagpur P.S. Case No. 291/2020)

State Vrs. Golu Kumar @ Ashok Kumar.

21-06-2021 A bail application u/s 12 of Juvenile Justice Act has been filed on behalf of petitioner Golu Kumar @ Ashok Kumar, who is in protective custody since 27-10-2020 in connection with Kharagpur P.S. Case No. 291/2020 u/ss 302/201/120(B)/34 of I.P.C. and pressed today for hearing. A certificate has been given in para-2 of the bail application that no any bail application has been filed either before this Court or before the Hon'ble High Court, Patna.

The allegation against the petitioner is that he alongwith other co-accused murdered the husband of informant by sharp cutting weapon.

Ld. Counsel for the petitioner submits that petitioner is innocent, he has committed no offence and has been falsely implicated in this case. He further submits that no case u/s 302 of I.P.C. is made out against the petitioner. He further submits that petitioner is in protective custody since 27-10-2020 and he has no criminal antecedent. Hence, petitioner may kindly be enlarged on bail

Ld. Spl. P.P. opposed the bail application.

I have heard the Ld. Defence Counsel and Ld. Spl. P.P. and also perused the case record.

From perusal of case record it transpires that petitioner is F.I.R. named and in protective custody since 27-10-2020. He was declared child in conflict with law alleged to be involved in heinous offence by Juvenile Justice Board vide order dated 19-03-2021 and 08-04-2021. Allegations against him are that he alongwith other co-accused came to the house of informant in the evening at around 07-30 P.M. and took her husband alongwith them for party and in the morning he was found dead near canal. His throat was slit and he has injuries over skull. Charge sheet against this petitioner has filed. Petitioner has no criminal antecedent as mentioned in the Social Investigation Report of this petitioner, who is a child in conflict with law showing that he is a student of B.A. Part III and is not involved in a bad company. It is further mentioned that this petitioner or his family members have no criminal back ground.

Considering the facts and circumstances mentioned above, the bail

21-06-21 application of petitioner is hereby allowed. He is directed to be released on bail on furnishing bail bond of Rs. 10,000/- with two sureties each of the like amount with the condition that one of the bailors shall be father of the petitioner. Father of the petitioner is also directed to take care of the education of petitioner to be continued and also that he shall not come in contact with any bad element or criminal and further apprise this Court every three months about the well being of petitioner till the disposal of this case.
