1. The present bail application has been preferred by petitioner **Munna Yadav @ Manish Ranjan** S/o- Late Makhan Yadav, who is lying in judicial custody since 12.03.2026 in connection with Dharhara P.S. Case No. 130 /2025 u/ss 103(1), 3(5) of B.N.S. pending in the Court of Ld. A.C.J.M.-III, Munger

2. As per the F.I.R. the prosecution story in brief is that on 21.07.2025 informant's husband, as usual, went to his agricultural farm at about 10:00 AM. Further informant went to agricultural farm at about 03:00 PM with lunch for her husband and after having lunch her husband got busy in his work. That the informant sat there in the shade of a tree beside the road near her agricultural farm. That all the accused persons including the petitioner armed with weapons came there and tied her (informat) mouth with clothes and wrongfully restrained her. Further all the accused persons including the petitioner assaulted infromant's husband got expired. Informant regained consciounes, she somehow went to her home and told the whole incidence to her family and when her family reached at the spot they saw that he was died. Hence the information, based on which the above stated P.S. case was registered.

3. At the outset the Id. Counsel for the petitioner has certified that previously a regular bail application has been filed on behalf of the petitioner which has been withdrawn and after that an anticipatory bail application filed on behalf of the petitioner which has been rejected. Thereafter a Criminal Miscellaneous petitioner has been filed on behalf of the petitioner before the Hon'ble High Court Patna, which also has been withdrawn with liberty to surrender and seek on bail and except this no anticipatory or regular bail has been filed on behalf of the petitioner before this Court or before any other Court including the Hon'ble High Court. He also certified that **the petitioner has seven criminal cases pending against him.** He further submits that the petitioner is innocent and has not committed any offence

and further that he has been falsely implicated in the present case due to village politics. That the alleged sections are not made out against the petitioner and the allegations against him are general and omnibus in nature. That the real fact is that informant's husband died due to lightening while he was working in the field. That the present petitioner is lying in judicial custody since 12.03.2026. Therefore the Ld Counsel pleads that the present petitioner be enlarged on bail.

4. The Ld. A.P.P. has opposed the bail application of the petitioner.

5. Heard the submissions of respective Id. Counsels and perused the record of the case.

6. From perusal of the case record, it appears that the petitioner is the named accused of the FIR. That the allegation against the petitioner is that he was involved in committing the murder of the informant's husband. That the investigation in this case is not yet completed. That the petitioner has two criminal cases pending against him. That the present petitioner is lying in judicial custody since 12.03.2026.

7. Hence, considering the nature of allegations and the gravity of the offence, I am not inclined to accept the present bail application and consequently the same is hereby **Rejected**.
