ORDER BELOW EXHIBIT NO.1
(Date : 14/07/2026)

The applicant has prayed for pre-arrest bail under Section 482 of the Bharatiya Nagarik Suraksha Sanhita, 2023 as he apprehends his arrest in Crime No.285/2026, registered in Police Station Jintur, for the offenses punishable under Sections 123, 223, 274, 275, 3(5) of the Bhartiya Nyaya Sanhita, 2023 and Sections 26, 27, 30(2)(a), 59 of the Food Safety and Standard Act, 2006.

2. The State filed say at Exh.5. I have heard learned Advocate for the applicant and learned APP for the State.

Advocate for the accused submits that it is the case of the prosecution that the name and role of accused is not mentioned in the FIR. The police has seized the contraband Gutka and tobacco from Tara Pan Shop, Jintur. He submits that the applicant was falsely implicated in this crime and he was not at all concern with the seized prohibited Gutkha. He submits that there is nothing in FIR to connect the applicant with the crime. There is no possibility to abscond the applicant. The applicant is ready to abide by the conditions imposed by the Court, if released on bail. The learned APP opposed the application and submits that the applicant ran away from the spot. The custodial interrogation of the applicant is necessary for tracing, from where and from whom, the contraband articles were purchased and to trace out other culprits. He prays to reject the application.

3. I have gone through the FIR and case papers. The alleged contra banned articles are already seized from the Tara Pan Shop. Therefore, custodial interrogation of the applicant is not required for the purpose of investigation. Considering the nature of allegations made against the applicant, I think to grant relief of pre-arrest bail to the

applicant with the following order -

ORDER

1. The application is allowed.
2. In the event of arrest of applicant Sayyad Karim Sayyad Yasin, in connection with Crime No.367/2026 of Police Station Jintur, the applicant be released on bail, in the sum of Rs. 25,000/- (Rupees Twenty Five Thousand only) with a surety in a like amount, on the following conditions:
 - (i) The applicant shall make himself available for the interrogation by the police as and when required, under the written intimation to that effect, until further order or till filing the charge-sheet, whichever is earlier.
 - (ii) He shall not tamper with the evidence of prosecution in any manner.
3. Inform the concerned police station accordingly.
