- (1) Heard, learned P.P. for the State and the learned Counsel on behalf of the petitioner/accused Rahul Kumar, S/o- Chinnilal Paswan.
- (2) The petitioner is seeking regular bail under section 483 of the BNSS, in Kudhani P.S. Case No. 638 of 2021, registered under section 341,323,387,307,379,504,506/34 of IPC.
- (3) The petitioner is in judicial custody since 11.12.2025.
- (4) Ld. counsel for the petitioner submits that Cri. Misc. No. 32/2022 was filed by the petitioner before the Hon'ble High Court, which was rejected vide order dated 21.07.2022, thereafter no other bail petition either regular or anticipatory has been moved before this court or the Hon'ble High Court.
- (5) The Ld. Counsel for the petitioner submits that petitioner is innocent and has been falsely implicated in this case. Petitioner has clean antecedent. The allegation levelled against the petitioner is false and concocted.
- (6) The case of informant Dinanath Paswan, is that for the last few days the accused Rahul Kumar @ Aman Kumar was asked for Rs. 5 lakh ransom money and since he was unable to pay the same on 06.08.2021, around 5 PM, the accused surrounded him and Rahul Kumar assaulted him with a sharp weapon, while Chinnilal Paswan and Gita Devi helped him.
- (7) The learned P.P. for the state opposed the bail petition of the petitioner.
- (8) On perusal of the order-sheet it is reflected that the prosecution was directed to peruse the case diary along with injury report vide order dated 09.02.2026, however the same is still not on record despite several opportunities being granted.

(9) In the aforesaid facts and circumstances and considering the nature of allegation and the fact that he is first time offender and he is in custody since 11.12.2025 and the fact that no apprehension is shown on part of the prosecution that the accused would flee from justice or commit a similar offence, if released on bail, let the petitioner, namely Rahul Kumar, S/o- Chinnilal Paswan be released on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) with two sureties of like amount each to the satisfaction of the learned concerned court subject to the following conditions:-

- The petitioner shall co-operate with the investigation agency, as and when required.
- The petitioner shall not commit an offence in future.
- The petitioner shall not directly or indirectly make any inducement, threat, or promise to any person acquainted with the facts of the case.
- The petitioner shall not tamper with the evidence-witness in any manner.
