ORDER

11.05.2026. Instant application for grant of regular bail has been filed on behalf of above named accused/petitioner who has been in custody since 26.11.2025 in connection with Karza P.S. Case No. 225/2025, registered u/S 309(4) of B.N.S. & 27 of Arms Act.

Heard Mr. Himanshu, learned advocate for the accused/petitioner and Ms. Sangita Sahi, learned Addl. P.P. for the State.

Prosecution case, in brief, is that three boys riding on a motorcycle intercepted informant at about 3:30 a.m. on 07.08.2025 on a new overbridge near village- Chiknaura, while he was going to his house on his motorcycle and shot him in his leg and then fled away with his motorcycle.

Learned Advocate for the accused/petitioner has submitted that accused/petitioner is quite innocent. Besides this case, he is also accused in following cases:

- (i) Karza P.S. Case No221/2024- U/s 304, 3(5) of B.N.S;
- (ii) Karza P.S. Case No261/2024- U/s 304, 3(5) of B.N.S;
- (iii) Karza P.S. Case No223/2025-U/s 304, 3(5) of B.N.S;
- (iv) Karza P.S. Case No299/2025- U/s 309(4) of B.N.S & 27 of Arms Act.

Ld. Advocate for the accused/petitioner has also submitted that allegation against him is totally false and nothing has been recovered from possession of the accused/petitioner and there is absolutely no evidence against him and he has been in custody since 26.11.2025. So, he may also be granted regular bail.

On the other hand, learned Addl. P.P. for the State has vehemently opposed the prayer for grant of regular bail to the accused/petitioner.

After hearing learned advocates from both sides, this court perused certified copy of the F.I.R., copy of case diary, trial court record received and then finds that the F.I.R has been registered against unknown and this accused/petitioner has been remanded in this case on 26.11.2025 from the Karza P.S. Case No. 299/2025 after his confessional statement and recovery of Pan Card and Aadhar Card of the informant on the basis of his disclosure. Injury report mentioned in para- 66 of the case diary reveals that informant has received gun-shot injury, but perusal of trial court record shows that

Contd..... co-accused Dharmendra Kumar @ Dharmendra Sahni carrying similar allegation has
11.05.2026 been granted bail by the Hon'ble High Court, Patna vide order dated: 27.04.2026 passed in Cri. Misc. No. 27942/2026 and therefore, the case of this accused/petitioner stands on similar footing and so, this court is inclined to grant the accused/petitioner bail.

Accordingly, he is directed to be released on his furnishing bail bond of Rs.10,000/-(rupees ten thousand) with two sureties of like amount one of whom must be his close relative who shall state on affidavit his/her relationship with the accused/petitioner with condition that accused/petitioner will file undertaking before the concerned court that he will be well represented on each and every date fixed by the court and shall remain physically present as directed by the court and on his absence on two consecutive dates without sufficient reason, his bail bond shall be cancelled by the concerned court. The accused/petitioner will also file undertaking that he will not involve himself in similar kind of offences.

Accordingly, his regular bail petition is hereby **allowed**.
