ORDER

19.05.2026. Instant application for grant of regular bail has been filed on behalf of above named accused/petitioner who has been in custody since 16.03.2026 in connection with Karza P.S. Case No. 45/2025, registered u/Ss 123, 103(1), 3(5) of B.N.S.

Heard Mr. Chandra Bhushan Pd Singh, learned Advocate for the accused/petitioner as well as Ms. Sangita Sahi learned Addl. P.P. for the State.

Allegation against the accused/petitioner, in brief, is that he in conspiracy with co-accused Soni Kumari fraudulently administered poison to informant's father as a result of which he died. Reason for the occurrence is that informant's father used to object to the illicit relationship of the accused/petitioner with informant's sister-in-law, co-accused Soni Kumari.

Learned Advocate for the accused/petitioner has submitted that accused/petitioner is quite innocent. He has no criminal antecedents. His earlier prayer for bail has been rejected by this court and the Hon'ble High Court, Patna respectively vide order passed in A.B.P. No. 1659/2025 and Criminal Misc. No. 87127/2025. The learned advocate has further submitted that besides this case, accused/petitioner is also accused in Karza P.S. Case No. 08/2025 and he has been in custody since 16.03.2026. It has been submitted further that accused/petitioner resides about 2 Kms. away from the house of the informant and he was not present near the place of occurrence at the alleged time and date of occurrence. Furthermore, co-accused Soni Kumari has been acquitted and therefore, this accused/petitioner may also be granted bail.

On the other hand, learned Addl. P.P. for the State has vehemently opposed the prayer for grant of bail to the accused/petitioner.

Contd..... Having heard both sides and perused the certified copy of F.I.R., copy of
19.05.2026 case diary, record of S.Tr. No. 215/2025, this court finds that allegation against accused/petitioner is very serious and investigation against him is still pending. Furthermore, co-accused Soni Kumari in her confession before police has taken the name of this accused/petitioner who as per para 26 and 27 of the case diary was in constant touch with the co-accused Soni Kumari on the alleged date of occurrence and postmortem report reveals that informant's father has died due to poisonous effect of ingested substance.

So, considering the nature and seriousness of allegation against the accused/petitioner and other facts discussed above, this court is not inclined to grant accused/petitioner bail at this stage.

Accordingly, his bail petition is hereby **rejected**.
