ORDER

09.06.2026. Instant application for grant of regular bail has been filed on behalf of above named accused/petitioner who has been in custody since 02.03.2026 in connection with Karja P.S. Case No. 223/2025, registered U/s 304(2) of B.N.S.

Heard Mr. Sandeep Kumar, learned advocate for the accused/petitioner and Ms. Sangita Sahi, learned Addl. P.P. for the State.

Prosecution case, in brief, is that at about 3:30 p.m. on 6.08.2025, while informant was going towards her house, three persons riding on a motorcycle snatched her mobile, mangalsutra and ladies purse containing Rs. 2,000/- and drove off. Informant could not see the registration number of the motorcycle of the snatchers on which they were riding.

Learned Advocate for the accused/petitioner has submitted that accused/petitioner is quite innocent. Besides this case, he is also accused in following cases:

- (i) Kanti P.S. Case No. 367/2022- U/s 379, 414 of I.P.C.;
- (ii) Kanti P.S. Case No. 414/2023- U/s 379, 356 of I.P.C.;
- (iii) Kanti P.S. Case No. 176/2025- U/s 303(2), 305, 3(5) of B.N.S.
- (iv) Karza P.S. Case No. 221/2024- U/s 304, 3(5) of B.N.S.;
- (v) Karza P.S. Case No. 228/2025- U/s 304(5) of B.N.S. & 27 of Arms Act;
- (vi) Karza P.S. Case No. 291/2024- U/s 309(4) of B.N.S.;
- (vii) Saraiya P.S. Case No. 303/2023- U/s 379, 356 of I.P.C.;
- (viii) Saraiya P.S. Case No. 567/2023- U/s 379, 356 of I.P.C.;
- (ix) Rajepur P.S. Case No. 439/24- U/s 30(a) of Excise Act;
- (x) Panapur Kariyat P.S. Case No. 24/2025- U/s 309(6) of B.N.S.

Ld. Advocate for the accused/petitioner has also submitted that allegation against him is totally false and no incriminating article, looted money has been recovered from his possession and there is no electronic evidence against him. Furthermore, no proper investigation has been conducted in this case to find out who is the real culprit and on mere suspicion, the accused/petitioner was arrested. Moreover, he has been in custody since 02.03.2026. So, he may be granted bail.

Contd..... On the other hand, learned Addl. P.P. for the State has vehemently opposed
09.06.2026 the prayer for grant of bail to the accused/petitioner.

Perused the certified copy of F.I.R., copy of case diary and trial court record.

Having heard learned advocates from both sides and perused the documents mentioned above, this court finds that accused/petitioner has been in custody in connection with this case since 02.03.2026 and although he has criminal antecedents in as many as 10 cases of similar nature, the investigating officer has concluded investigation as regards this accused/petitioner and submitted charge-sheet against him. Moreover, investigating officer has been not able to collect any material against the accused/petitioner during the entire investigation except his confession.

So, considering the nature of allegation in the F.I.R. and other facts discussed above, this court is inclined to grant him bail.

Accordingly, he is directed to be released on his furnishing bail bond of Rs.10,000/-(rupees ten thousand) with two sureties of like amount subject to the condition that one of the sureties shall be his family member who shall state on affidavit his/her relationship with the accused/petitioner subject to further condition of his filing undertaking that he will not indulge in similar offences after his release from custody in this case.

Accordingly, his bail petition is hereby **allowed**.
