- (1) Heard, learned P.P. for the State and the learned Counsel on behalf of the petitioner/accused Soni Devi, W/o- Baleshwar Paswan.
- (2) The petitioner is seeking anticipatory bail under section 482(2) of the BNSS, in connection with Ahiyapur P.S. Case No. 867/2026 registered under sections 63, 69, 308, 351(2), 352, 79, 3(5), 123 of BNS.
- (3) Ld. counsel for the petitioner submits no other bail petition either regular or anticipatory has been previously moved before this court or the Hon'ble High Court.
- (4) The Ld. Counsel for the petitioner submits that petitioner is innocent and has been falsely implicated in this case. Petitioner has got no criminal antecedent. The entire allegation levelled against the petitioner is false and concocted. The occurrence took place on 18.01.2026 but the FIR was registered on 11.05.2026.
- (5) The case of the informant Heena Devi is that on 18.01.2026 Baleshwar Paswan, Soni Devi and Aashik Paswan called her asking her to come for an urgent work. Since Soni Devi is her sister, she went to Zeromile Ahiyapur where Baleshwar Paswan came and took her to Valention Hotel on the highway where all the three were present and they gave her cold drink to drink after which she fell unconscious. When she got up, there was no clothes on her body and when she tried to wear her clothes, Aashik Paswan made a video of her and Baleshwar Paswan committed wrong with her and threatened her of dire consequences. She came to Kachchi Pakki and then informed her relative Abhishek who came on a motorcycles and took her home. She further alleged that Baleshwar Paswan had taken Rs. 2 lakh from her and still asking for more. She told the entire story to her husband and since she was scared and she did not file the case in time.

- (6) The learned P.P. for the state opposed the anticipatory bail petition of the petitioner.
- (7) On perusal of the record, it is reflected that the occurrence took place on 18.01.2026 and the FIR was registered on 11.05.2026 and in addition to that, the accused and the informant are close relatives, the accused being the sister of the informant. The informant and her husband were present in the court on 09.07.2026 wherein the video was shown by the husband to the court on his mobile. From the said video, it was apparent that the victim was not under any duress and pressure and was seen talking to the accused comfortably negating the facts stated in the FIR.
- (8) Considering the above fact and circumstances and the fact that petitioner is first time offender and no apprehension is shown on part of the prosecution that the accused would flee from justice or commit a similar offence, if released on bail, in the event of her arrest or surrender in the court concerned within four weeks from the date of communication of this order, let the petitioner namely, Soni Devi, W/o- Baleshwar Paswan be released on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) with two sureties of like amount each to the satisfaction of the learned concerned court subject to the following conditions:-
- The petitioner shall co-operate with the investigating agency as well as trial.
 - The petitioner shall not commit an offence in future.
 - The petitioner shall not directly or indirectly make any inducement, threat, or promise to any person acquainted with the facts of the case.
 - The petitioner shall not tamper with the evidence-witness in any manner.
