- (1) Heard, learned P.P. for the State and the learned Counsel on behalf of the petitioner/accused Aman Kumar, S/o- Rambabu Tiwari.
- (2) The petitioner is seeking regular bail under section 483 of the BNSS, in Sahebganj P.S. Case No. 612 of 2025, registered under section 329(3), 126(2), 115(2), 118(1), 118(2), 109, 352, 3(5) BNS.
- (3) The petitioner is in judicial custody since 22.10.2025.
- (4) Ld. counsel for the petitioner submits that no other bail petition either regular or anticipatory has been previously moved before this court or the Hon'ble High Court.
- (5) The Ld. Counsel for the petitioner submits that petitioner is innocent and has been falsely implicated in this case. Petitioner has clean antecedent. The allegation levelled against the petitioner is false and concocted.
- (6) The case of informant Jintedra Kumar is that on 20.10.2025, while children were playing with crackers on the occasion of Diwali, Aman Kumar whose field is near his house with paddy crop standing, came hurling abuses saying the crackers would cause fire in his paddy field. Thereafter, the children went to an open field to burst the crackers. After sometime the accused came to his house with knife and struck Mukesh Kumar with it, injuring him. When the informant went to his rescue, he too was hit with the knife. The accused is also alleged to have been assaulted.
- (7) The learned P.P. for the state opposed the bail petition of the petitioner.

- (8) On perusal of the order-sheet it is reflected that the prosecution was directed to peruse the case diary along with injury report vide order dated 17.12.2025, however the same is still not on record despite several opportunities being granted. The petitioner is in custody since 22.10.2025.
- (9) In the aforesaid facts and circumstances and considering the nature of allegation and the fact that he is first time offender and he is in custody since 22.10.2025 and the fact that no apprehension is shown on part of the prosecution that the accused would flee from justice or commit a similar offence, if released on bail, let the petitioner, namely Aman Kumar, S/o- Rambabu Tiwari be released on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) with two sureties of like amount each to the satisfaction of the learned concerned court subject to the following conditions:-
- The petitioner shall co-operate with the investigation agency, as and when required.
  - The petitioner shall not commit an offence in future.
  - The petitioner shall not directly or indirectly make any inducement, threat, or promise to any person acquainted with the facts of the case.
  - The petitioner shall not tamper with the evidence-witness in any manner.
