	07-04-2026	<p>The present petition for regular bail filed on behalf of petitioner Ashok Kumar, who is in judicial custody since 24.02.2026 in connection with Harnaut P.S. Case No. 332/2021 registered U/s-341, 323, 379, 304, 448, 504, 506/34 I.P.C., is pressed today.</p> <p>The prosecution story as per the written report of the informant Surendra Prasad, in brief, is that on 31.07.2021 at 2:00 P.M., the accused Shiv Shambhu Kumar, Ashok Kumar and Bablu Kumar came at his door and started abusing and assaulting. The accused Shambhu Kumar assaulted his mother with iron rod by which she sustained injury. The accused Ashok Kumar caught her hand and snatched her gold chain worth Rs. 52,000/-. The accused Bablu Kumar broke the lock of the box and took away cash. It has been further alleged that the accused persons are of criminal nature and they threatened to vacate the house otherwise, they will kill them and also drag in false cases.</p> <p>Heard the learned counsel Shri Dinesh Prasad for the petitioner as well as the learned A.P.P. Sri Amir Singh on behalf of the State.</p> <p>It has been submitted by the learned counsel on behalf of the petitioner that the petitioner is innocent and has committed no offence and he has falsely been dragged in the present case. The allegation against the petitioner is entirely false, baseless and concocted. The present case was lodged as a counterblast to Harnaut P.S. Case No. 331/2021 u/s 341, 323, 385/34 of the IPC in which accused Shiv Shambhu Kumar is the informant and sons of the informant are accused. Both the sides are on litigating terms from before due to land dispute and several cases have also been lodged from the petitioner's side against the informant's family. The injured Basmati Devi who was the mother of the informant died on 09.08.2021 at home, i.e., nine days after the occurrence and Post mortem was done but the cause of death was not ascertained and opinion was kept reserved till viscera report. The petitioner is also accused in Harnaut P.S. Case No. 335/21 and complaint Case No. 432C/18 in which he is on bail. Both the cases are with prosecution side of the present case. He also submits that the petitioner is in custody since 24.02.2026. On these facts, he has prayed that the petitioner be granted regular bail.</p> <p>The learned A.P.P. opposed the prayer for the bail.</p> <p>Having gone through the case record, it appears that this case has been registered u/s 341, 323, 379, 304, 448, 504, 506/34 I.P.C against the petitioner and other accused persons and the allegation against the petitioner is that he caught the hand of the informant's mother and snatched her gold chain. Also, he is in judicial custody since 24.02.2026.</p>
