	30-03-2026	<p>The present petition for regular bail has been filed on behalf of the petitioner Ajay Kumar, who is in custody since 03.02.2026 in connection with Telmar P.S. Case No. 90/2025, u/s 136 Indian Electricity Act, is pressed today.</p> <p>The prosecution story as per the written report of the informant Deepak Kumar, J.E., in brief, is that on 10.12.2025 at about 8:00 AM he got information on the departmental number that the LT cable installed for agricultural work at Jharha Khanda and Kira Khandah of village telmar had been cut and stolen by unknown thieves during the previous night. Thereafter, the informant along with his co-staff working under his sub-division reached at the place of occurrence at about 10 AM and it was found that unknown thieves had cut and stolen approximately one kilometer of LT cable from Jharha Khanda in village Telmar, worth Rs. 2,48,000/- and about one and a half kilometers of LT cable from Kora Khanda worth Rs. 3,37,000/-. Total, LT cable spanning about fifty poles was cut and stolen.</p> <p>Heard the learned counsel Shri Shailendra Kumar Savita for the petitioner as well as learned A.P.P. Shri Sunil Kumar Sinha on behalf of the State.</p> <p>It has been submitted by the learned counsel on behalf of the petitioner that the petitioner is innocent and has committed no offence and he has falsely been implicated in this case. The alleged prosecution story is false, concocted and fabricated and there is no truth at all. Nothing incriminating material has been recovered from the possession of the petitioner. The petitioner has been arrested in Harnaut P.S. Case No. 576/2025 and the police has remanded the petitioner on 03.02.2025 from that case. The petitioner is in judicial custody since 03.02.2026. On these facts, he has prayed that the petitioner be granted regular bail.</p> <p>The learned A.P.P. opposed the prayer for bail.</p> <p>The case diary was called for on 18.03.2026 but the same has not been received. So, the court has no option but to pass order in absence of case diary.</p> <p>Having gone through the case record, it appears that this case has been registered u/s 136 Indian Electricity Act and it also transpires that the petitioner is not named in the F.I.R. and he has been made accused on the basis of confessional statement of co-accused Brajesh Kumar. The petitioner is in judicial custody since 03.02.2026.</p> <p>Thus, considering the aforesaid facts and circumstances of the case, the petitioner <b>Ajay Kumar</b> is directed to be released on bail on furnishing bail bond of Rs. 10,000/- with two sureties of like amount</p>
