	04-07-2026	The anticipatory bail petition dated 16.04.2026 received to this Court on 20.04.2026 filed on behalf of the petitioner Jayshankar Sharma who is apprehending his arrest in connection with Complaint ase No. 756C/2015, dated 17.06.2015 registered U/s 233, 379, 504, 498(A)/34 of the IPC, has been placed before me for order after hearing, a copy of it has already been supplied to the learned P.P. Heard the learned counsel Sri Navin Kumar for the petitioner as well as learned P.P. Sri Anuj Kumar on behalf of the State. The prosecution story as per the complaint petition of the complainant Baby Sharma, in brief, is that the marriage of the complainant was solemnized with Jayshankar Sharma on 25.04.2000 at village Raghunathpur with Hindu rites and rituals and at the time of marriage her father gave Rs. 40,000/- cash and jewellery and other articles worth Rs. 1 lakh and also he gave the clothes and two gold rings etc. to Jayshankar Sharma. After that she went to her matrimonial home and lived there properly for four years. She gave birth to two girl children. After giving birth to her second baby girl, the complainant's sister in law Nirmala Devi and the husband of Nirmala Devi, namely, Sikandar Sharma and her husband started torturing her for demand of Rs. 1 lakh as dowry. After sometime, she gave birth to a girl child. Again, after sometime, she gave birth to a son. But the accused persons kept on torturing her for demand of dowry of Rs. 1 lakh. On 12.11.2011 all the accused persons assaulted the complainant and sprinkled kerosene oil on her and made her fled away along with her children for the abovesaid dowry demand. They also kept all her jewellery and other belongings. The learned counsel for the petitioner has submitted that the petitioner is innocent and has committed no offence and has falsely been implicated in this case. He is not having any criminal antecedent. Also, he submitted that the petitioner is ready to lead conjugal life with her wife and he is assuring that he will keep her with full dignity and honour. On these facts, he prayed that the petitioner be granted anticipatory bail. The learned P.P. conceded with this fact. Having gone through the case record, it transpires that this case has been registered u/s 233, 379, 504, 498(A)/34 of the IPC. It appears that the petitioner is the husband of the complainant and he is ready to keep his wife with full honour and dignity. The

Moreover, the alleged offences are punishable for less than seven years. Thus, considering the aforesaid facts and circumstances of the case, the petitioner Jayshankar Sharma is directed to be admitted on anticipatory bail on furnishing his bail bond of Rs. 10,000/- with two sureties of like amount each to the satisfaction of the learned trial Court within one month from the communication of this order subject to the conditions as laid down under Section 438 Cr.P.C.
