(1) This Anticipatory Bail application has been filed on behalf of the petitioners, namely 1. Niti Singh @ Rajniti Singh and 2. Nilu Devi @ Malti Devi, Both resident of Village- Barara, P.S.- Noorsarai, District- Nalanda, in connection with Noorsarai P.S. Case No. 195/2026 registered U/S- 126(2), 115(2), 109, 351(2), 352, 3(5) B.N.S. <u>PROSECUTION CASE</u> (2) Prosecution case in brief is that on 21.03.2026, the informant Upendra Singh was on his door-steps, when Niti Singh and Nilu Devi beat him. Niti Singh throw him on the floor and hit him with cane, due to which his head was ruptured. Nilu Devi also hit him with the cane, due to which his forehead was ruptured. <u>SUBMISSION OF THE COUNSEL OF THE PARTIES</u> (3) The learned counsel for the petitioners has prayed for grant of the anticipatory bail and has submitted as under: ● That the petitioners are innocent and have not committed any offence. ● They have not filed any regular or anticipatory bail petition either before this Court or before Hon'ble High Court Patna.

	● Petitioner No. 1 has three criminal antecedents. ● That the date of occurrence is 21.03.2026 but F.I.R. was lodged on 29.03.2026 and no explanation has been given for delay. ● There is case and counter-case between the parties. (4) On the other hand, the learned APP has vehemently opposed the bail petition and has submitted that the offences are serious in nature and therefore they do not deserve the benefit of anticipatory bail. <u>MATERIAL ON RECORD AND FINDINGS</u> (5) From the perusal of the record, it transpires that the informant and the witnesses have supported the prosecution case in paragraph 2, 6 and 7 of the case diary. The injury report of Upendra Singh is reproduced in Para No. 32 of the case diary, as per which he has following injuries:- a. Abrasion on right hand. b. Abrasion on left hand. c. Pain at back. d. Pain and swelling on right leg. All the injuries are stated to be simple in nature caused by hard and blunt object. The injuries are not on the vital part of the body and are very minor in nature. There is delay in filing of F.I.R. (6) Considering all these circumstances, anticipatory bail is allowed and petitioners are directed to be released on bail on furnishing bail bond of ₹10,000/- with two sureties of the like amount each, to the satisfaction of the learned Trial Court, in the
