	22-06-2026	The present petition for regular bail has been filed on behalf of the petitioner Karu Paswan, who is in custody since 05.05.2026 in connection with Rahui P.S. Case No. 681/2025 u/s 191(2), 190, 126(2), 115(2), 109(1), 352, 351(2) of the B.N.S., is pressed today. The prosecution story as per the written report of the informant Pushpa Devi, in brief, is that on 10.12.2025 at around 08:00 P.M., she was in her house with her family. The accused Tunnu Paswan, Nitish Paswan, Kunal Paswan, Sajan Paswan, Arvind Paswan, Libu Paswan, Karu Paswan, Nanhe Paswan, Sarvila Devi, Sarita Devi, Savitari Devi, Baby Devi, Soni Devi, unanimously came to her house using abusive language iron rods, sticks, bricks and stones and asked to withdraw the case which was filed by her Bhaisur Deepak. When she protested to it, the accused Kunal Paswan assaulted her with lathi by which she sustained injury at her chin. When the informant's Bhaisur namely Deepak Kumar and Gotani Runa Kumari, mother in law Saroj Devi and brother in law Satyendra Paswan came to save her, the accused Karu Paswan assaulted Deepak Kumar with iron rod by which he sustained injury at his head and he fell down. It has been further alleged that all the accused persons assaulted and injured Rinki Devi, Nishu Kumari, Kari Devi, Runa Devi, Saroj Devi and Satyendra Paswan with iron rod, bricks and stones. Heard the learned counsel Sri Barun Kumar for the petitioner as well as the learned P.P. Sri Anuj Kumar on behalf of the State. It has been submitted by the learned counsel on behalf of the petitioner that the petitioner is innocent and has committed no offence and has falsely been implicated in this case. The alleged prosecution story is false, fabricated and motivated. There is counter case so only to save the skin from the counter case, this false case has been lodged. In the counter case Tunnu Paswan and his wife Soni Devi have sustained grievous injury. Further, the petitioner is not having any criminal antecedent and he is in custody since 05.05.2026. On these facts, he has prayed that the petitioners be granted regular bail. The learned P.P. opposed the prayer for bail. Having gone through the case record, it appears that this case has been registered u/s 191(2), 190, 126(2), 115(2), 109(1), 352, 351(2) of the B.N.S. and the allegation against the petitioner is that he along with other accused persons came to the house of the informant and the petitioner assaulted the Bhaisur of the informant, namely, Deepak Kumar with iron rod by which he sustained injury at his head. Though the injury report of the Deepak Kumar reflects that the injury sustained by him is grievous in nature but it also reflects that there is no repeated blow. Further, there is case and counter case between both the parties. Also, the chargesheet has already been submitted in this case and nowhere in the entire case diary it has come that the petitioner ever tried to tamper with the evidence. Further, as per para-57 of the case diary, the petitioner is having criminal antecedent. Moreover, the petitioner is in judicial custody since 05.05.2026. Thus, considering the aforesaid facts and circumstances of the case, the petitioner Karu Paswan is directed to be released on bail on furnishing
