	12-06-2026	The present petition for regular bail filed on behalf of petitioner Dharamveer Paswan @ Mithun Paswan, who is in judicial custody since 16.01.2026 in connection with Bihar Sharif P.S. Case No. 427/2025 registered for the offences punishable u/s 126(2), 115(2), 76, 109(1), 351(2), 3(5) of the B.N.S. & 27 Arms Act, is pressed today. The prosecution story as per the written report of the informant Madhumati Devi, in brief, is that on 10.07.2025 at around 6:00-6:30 P.M. while she was opening her shop, her tenants namely Karu Paswan, Swarath Paswan, Shashi Paswan, Ravi Paswan, Mithun Paswan attacked on the informant just after she opened her shop. The accused Karu Paswan, a liquor mafia, brandishing pistol in his both hands, threatened to kill the informant and prevented her from opening her shop, and also threatened to commit rape on her and kill her husband along with her children, and take over her shop and house. When she didn't respond the accused Karu Paswan, holding a pistol in his both hands, fired in the air to scare her, which could have killed her. the accused Swarath Paswan and Shashi Paswan pulled her saree and tore that, while Mithun Paswan caught her hand and the accused Ravi Paswan started pressing her eyes and kept on pressing her neck. Heard the learned counsel Shri Barun Kumar for the petitioner as well as the learned P.P. Shri Anuj Kumar on behalf of the State. It has been submitted by the learned counsel on behalf of the petitioner that the petitioner is innocent and has committed no offence and he has falsely been dragged in this case only to put pressure and save his skin from the previous case and Title Suit Case No.136/2018 pending in the Court between the same party. The petitioner was neither present on the place of occurrence nor involved in the present case rather he has been made an accused because he is the brother of Karu Paswan and the co-accused Shashi Paswan has already been granted bail vide ABP No. 213/2026 and Swarath Paswan has also been granted bail vide B.P. No. 176/2026 by this Court. The petitioner has also another case in between the same party in which he is on bail and he has been remanded in from another case i.e. Bihar P.S. Case No. 697/2025 on 16.01.2026. He also submits that the petitioner is in custody since 16.01.2026. On these facts, he has prayed that the petitioner be granted regular bail. The learned P.P. opposed the prayer for the bail. Having gone through the case record, it appears that this case has been registered u/s 126(2), 115(2), 76, 109(1), 351(2), 3(5) of the B.N.S. & 27 Arms Act and the only allegation against the petitioner is that he caught hold of the hand of the informant and the co-accused Ravi Paswan started pressing her eyes and neck. It also appears that there is no injury report on the record. Also, the co-accused persons have already been granted bail. Moreover, the petitioner is in judicial custody since 16.01.2026.
