1. Heard learned counsel for the petitioner Vijay Yadav who is in judicial custody since 25.05.2026 in connection with Manpur P.S. Case No. 15/2008 registered u/s 379 and 411 of the I.P.C.. Also heard learned P.P. for the State.

2. Learned counsel for the petitioner submitted that earlier the petitioner was arrested by the Police and sent to judicial custody. After submission of charge-sheet, cognizance under Sections 379 and 411 of the I.P.C. was taken against him. He was released on bail vide B.P. No. 679/2008 and his bail bond was cancelled on 23.09.2010. Subsequently, process under Section 82 and 83 of the Cr.P.C. were issued against him. The petitioner belongs to other District and he is illiterate person of poor background. He was arrested by the Police on the basis of permanent warrant and sent to judicial custody on 25.05.2026.

3. On the other hand, Learned P.P. opposed the prayer for bail.

4. Perused the case record. The case was registered against the petitioner under Sections 379 and 411 of the I.P.C.. He was remanded to judicial custody on 25.04.2008. After submission of charge-sheet, cognizance was taken against the petitioner under Sections 379 and 411 of the I.P.C. on 24.05.2008. He was released on bail on 02.06.2008 vide order dated 31.05.2008 passed in B.P. No. 679/2008. The case remained for supply of Police paper. On 23.09.2010, bail bond of the petitioner was cancelled and NBW was ordered to be issued. On 04.04.2019, process under Section 82 of the Cr.P.C. was ordered to be issued. Thereafter, process under Section 83 of the Cr.P.C. was issued against the petitioner. On 12.02.2025, permanent warrant of arrest was issued against the petitioner. The petitioner was produced before the Learned Court concerned on 25.05.2026 on the basis of permanent warrant. He was remanded to judicial custody and since then, he is in judicial custody.

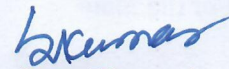
