	20-04-2026	<p>The anticipatory bail petition dated 22.12.2025 received to this Court on 08.01.2026 filed on behalf of the petitioners, namely, (1) Rahul Kumar, (2) Malti Devi @ Lalita Devi, (3) Mithilesh @ Akhilesh Singh and (4) Anju Devi, who are apprehending their arrest in connection with Nalanda P.S. Case No. 215/2025, dated 01.12.2025 registered U/s 126(2), 115(2),85, 352, 109(1), 123, 3(5) of the BN.S. and 3/4 D.P. Act., has been placed before me for order after hearing, a copy of it has already been supplied to the learned Addl. P.P.</p> <p>Heard the learned counsel Sri Ashok Kumar Singh for the petitioner as well as the learned Addl.P.P. Sri Amir Singh on behalf of the State.</p> <p>The prosecution story as per the written report of the informant Gudiya Devi, in brief, is that she solemnized the marriage of her younger daughter namely Madhu Kumari with Rahul Kumar one and a half years back. After the marriage her daughter's husband, father-in-law Mithilesh @ Akhilesh Singh, mother-in-law Malti Devi, sister-in-law Anju Devi started demanding motorcycle, refridgerator and cooler in dowry. Due to non-fulfilment of their demand, they started abusing and assaulting her daughter. It has been further alleged that on 14.10.2025 the mother-in-law and father-in-law of her daughter forcibly administered poison to her but they took her to the hospital for her treatment.</p> <p>The learned counsel for the petitioners has submitted that the petitioners are innocent and have committed no offence rather they have falsely been implicated in this case. The informant's daughter Madhu Kumari is happily residing at her matrimonial house and she is in family way. The petitioners have got no any criminal antecedent. On these facts, he prayed that the petitioners be granted anticipatory bail.</p> <p>The learned Addl.P.P. opposed the prayer for anticipatory bail of the petitioners.</p> <p>Having gone through the case record, it appears that this case has been registered U/s 126(2), 115(2),85, 352, 109(1), 123, 3(5) of the BN.S. and 3/4 D.P. Act. The petitioners are the husband and in-laws of the informant's daughter. The victim and her husband (petitioner) are present before the Court and victim submits that she is living happily with her husband and she is in family way and no such occurrence took place with her. The husband/ petitioner also assures the Court that he will keep his wife full honour and dignity</p>
