This Bail petition has been filed on behalf of petitioner **Gorelal Chaudhary** who is in custody since 24.11.2025 in connection with **Kadirganj P.S Case No. - 231/2025**, registered U/Ss. U/Ss. 191(2)/191(3)/190/126(2)/115(2)/118(1)/109/303(2)/352 B.N.S. Copy of this B.P. has already been served to the Ld. A.P.P.

Prosecution story, in short, is that on on dated 02.08.2025 at about 08:00 P.M. informant along with his cousin Ratan Kewat was going to Gaya by pick-up to buy fish cumin. When they reached near Kunjaila Pool, then water accumulated on the road fell on accused Badal Chaudhary due to the tyre of informant's pick-up. Then petitioner called other co-accused persons and surrounded the informant's vehicle. Then they took the driver Ratan Kewat out of the vehicle and started assaulting on his head. When informant tried to save him, then the accused persons started assaulting him and he fell on the ground. Ratan Kewat's head got injured and he fainted. He further alleged that the accused Badal Chaudhary snatched Rs. 1,62,000/- cash from the pocket of Ratan Kewat, which he had kept to buy the fish cumin. It is further alleged that accused Soldier Chaudhary snatched gold locket from the neck of Ratan Kewat and petitioner Nitish Chaudhary snatched gold locket from the neck of the informant.

Ld. Counsel for the petitioner submitted that petitioner is innocent and has not committed any offence as alleged and he has falsely been implicated in this case. Petitioner has no criminal antecedent. Petitioner is in custody since 24.11.2025.

Learned P.P. opposed the prayer for bail of the petitioner.

Heard both sides and perused the case record. Petitioner is named in F.I.R. Witnesses have supported the occurrence in para 4, 5 and 64 of case diary. Injury report of injured Ratan Kewat shows (I) lacerated wound on left parietal region of size 105”x1/4”x1/4 (ii) lacerated wound of occipital region of eye size 2”x1/4”x1/6” and nature of injury was found to be grievous. Injury report of Satrudhan Kumar shows lacerated wound on left parietal region. Allegation against petitioner is serious in nature. Investigation in this case is still going on.

In view of the aforesaid facts and circumstances of the case and the nature of allegation, the petitioner is not entitled to be enlarged on bail, as such his prayer for granting regular bail is hereby **rejected** at this stage. However, petitioner may renew his prayer for bail after submission of charge sheet, if so advised.
