counsel for the applicant as well as the verification report of IO with respect to the marriage of brother in law of applicant/accused, the present application is allowed. Let, applicant/accused **Yogesh @ Sonu** be permitted to custody parole for **three hours for 24.04.2024 from 3:00 P.M. to 6:00 P.M. at G-2, B-3-22, Aryavart Apartment, Narela, Delhi (excluding the time to be taken into and fro).** The concerned Jail Superintendent is directed to take the applicant/accused to the aforesaid venue on 24.04.2024 and he may be re-lodged in he prison immediately, thereafter. As regards the submission of ld. counsel for the applicant/accused that the applicant/accused may be taken at the venue of the marriage without handcuffs and fetters and the escorting staff may be directed to be in plain civil clothes, is left at the discretion of concerned Jail Superintendent, who shall decide the same taking into consideration the fact that the present applicant/accused is in the category of high risk.

**Let copy of this order be sent to concerned Jail Superintendent through special messenger as well as through E-mail, with direction to take the applicant/accused on 24.04.2024 between the aforesaid relevant time period and to lodge him back in the jail.**

Compliance report in this regard be also sent to the Court. The above said application be tagged with the main file. **Copy of order be given Dasti to Ld. counsel for applicant/accused.**
