- 1.** The **petitioner, Golu Kumar**, seeks anticipatory bail in connection with **Pirbahore P.S. Case No. 147/2026**, registered under Sections 62 and 303(2) of the Bharatiya Nyaya Sanhita, 2023 (BNS).
- 2.** The prosecution case, as narrated by the informant J.P. Sharma, Assistant Manager (General Administration) at the National Institute of Technology, Patna, is that on 14.02.2026 at around 6:00 AM, two individuals were spotted fleeing after stealing materials from the underground store of the Chemistry Department. When security personnel attempted to apprehend them, they escaped, abandoning both the stolen items and a Honda scooty bearing registration number BR-01CP-9350.
- 3.** Learned counsel for the petitioner submits that the only non-bailable offence alleged is under Section 303(2) of the BNS, which prescribes a maximum punishment of five years imprisonment and is triable by a Magistrate. It is further argued that the FIR was lodged against two unidentified persons. The petitioner apprehends arrest solely because the scooty left at the scene is registered in his name. Learned counsel clarifies that although the vehicle belongs to the petitioner on record, he had sold it to one Nidhi Kumari on 09.09.2025, well before the incident dated 14.02.2026. However, the registration was not formally transferred to the buyer, and thus continues to stand in his name. The petitioner is stated to have an unblemished criminal record.
- 4.** For a better appreciation of this anticipatory bail petition, the office is directed to **call for the case diary** along with the criminal antecedents of the petitioner from the Investigating Officer.
- 5.** At this juncture, learned counsel for the petitioner prays for interim

protection against arrest.

6. Taking into account the facts and circumstances of the case, the submissions advanced on behalf of the petitioner, and his clean antecedent, ***interim protection from arrest is granted to the petitioner in connection with Pirbahore P.S. Case No. 147/2026 until the next date of hearing.*** The petitioner is directed to cooperate with the Investigating Officer and remain available as and when required by the police.
7. Re-list this case on 24.03.2026.
