This bail application is preferred by **Gaurav Kumar S/o-**

Mukesh Sharma in connection with Gandhi Maidan P.S. Case No. 19/2021, registered U/s- 419, 420, 467, 468, 471, 120B of I.P.C. which is pending in the Court of SDJM, Patna.

The prosecution case in brief is that Silki Sharma lodged an FIR stating that an account was fraudulently opened in her name at ICICI Bank, Exhibition Road, Patna without her knowledge or consent, through which unauthorized transactions were carried out. She came to know about this on 21.12.2020 through Delhi Police, denied any connection with the account, and alleged involvement of bank officials in opening the account without proper verification, seeking legal action against those responsible.

Ld. Counsel for the petitioner submitted that the petitioner had not moved any anticipatory or regular bail either before this court or before the Hon'ble High Court. It had been submitted that petitioner had no criminal antecedent. It had been further submitted that petitioners are innocent and falsely been implicated in this case and the entire allegations against the petitioner are false and baseless. There is no chance of absconding or tampering with the evidence and ready to abide by them terms and conditions of bail. Hence, prayed to enlarge the petitioners on bail.

Ld. A.P.P. appeared on behalf of the state and submitted that the petitioner had committed serious offence. Hence, prayed to reject the bail petition.

Heard the Ld. Advocates of both the parties and perused case diary of Gandhi Maidan P.S. Case No. 19/2021, registered U/s- 419, 420, 467, 468, 471, 120B of I.P.C. against the petitioner. Petitioner is accused of opening of bank
