**ORDER**

1. A petition dated **31/01/2026**, for grant of anticipatory bail filed on behalf of above named **sole** petitioner who is apprehending his arrest in connection with **Mokama P.S Case No. 483 of 2025**, for the alleged have committed offenses punishable u/s 126(2), 115(2), 109(1), 352 r/w 3(5) BNS, pressed today.

2. Heard, L.d. Counsel for the petitioner as well as L.d. Addl. Public Prosecutor (APP), appearing on behalf of the State.

3. Prosecution case, *in brief*, as per written report of **informant Rohit Kumar**, is that on 26/12/2025 at 09:30 PM, Vidya Bind & others abused & assaulted him with *fist & lathi*, due to which, he sustained injury on various part of body including head and blood oozed out.

4. At Para- 2 & 3 of the bail petition, certificate has been given by petitioner that earlier no regular or anticipatory bail either before L.d. Court of Sessions or before Hon'ble High Court has been filed, nor any bail application is pending before any Court and he has **no** criminal antecedent. Petitioner is innocent and has falsely been implicated in the present case. It is submitted that from perusal of FIR, or whole of the record it would appear that there is no any specific allegation against the petitioner rather the same is general and omnibus. It is submitted that the petitioner has no concern with this incident. Petitioner is ready to furnish bail bond with sound sureties & obey each and every conditions imposed by Court, if bail is granted.

5. L.d. A.P.P. appearing on behalf of State vehemently opposed the prayer of petitioner for anticipatory bail and submitted there is serious allegation against the petitioner. **Cont'd/-...**

6. Trial Court Record (T.C.R.) & case diary (CD) have been received. Heard, rival contentions of both the parties and perused the record. From perusal of record, it transpires that there is direct & specific allegation against accused petitioner that he alongwith other co-accused persons have abused & assaulted informant with with *fist & lathi*, due to which, he sustained injury **on various part of body including on head and blood oozed out**. As per injury report attached with case diary, Rohit Kumar sustained three injuries on his person, out of which, one is **on vital part of body i.e., on head (right parietal sculp)**. Other co-accused persons who were arrested by police have been **granted regular bail after being custody for about 20 days**. Informant in her re-statement & other witnesses at **different paras of case diary have supported the version of FIR**. Investigation is still going on, new facts may emerge.

7. Considering the aforesaid facts and circumstances, criminal antecedents, **nature, gravity and seriousness of accusation**, this Court is not inclined to grant privilege of anticipatory bail to the petitioner. *Accordingly*, prayer for anticipatory bail on behalf of above named of **sole** petitioner is hereby **Rejected**. Let the copy of this order be sent to the concerned Trial Court.
