ORDER

1. A petition dated **16/02/2026**, for grant of anticipatory bail filed on behalf of above named accused petitioners, who are apprehending their arrest in connection with **Bhadaur P.S. Case No. 09 of 2026**, for the alleged have committed offences punishable u/s 318(4), 336(2), 338, 336(3), 329(3) r/w 3(5) BNS, *pressed today*. A copy of bail petition has already been served to the Ld. APP.

2. Heard, Ld. Counsel for the petitioners as well as Ld. Addl. Public Prosecutor (APP), appearing on behalf of the State.

3. Prosecution case, *in brief*, as per *written report* of **Farjana Khatoon**, is that her husband Late Abdul Rakib got certain land from his maternal uncle Late Md. Ibrar through registered *Hibbanama* in the year 2003. After death, she was coming on peaceful possession of the said lands. In the year 2018, Md. Sarbar illegally got the land entered into Registered-2 of revenue department. Thereafter, Md. Sarbar sold the land to various criminals, who are cultivating on the same by taking possession.

4. At Para- 2 & 3 of the bail petition, certificate has been given by petitioners that earlier no regular or anticipatory bail either before Ld. Court of Sessions or before Hon'ble High Court has been filed, nor any bail application is pending before any Court. Petitioners have **no** criminal antecedent. The petitioners have no connection with both parties. There is dispute between both the family members and petitioners are not a family members. Petitioners are ready to furnish bail bond with sound sureties & obey each and every conditions imposed by Court, if bail is granted.

5. Ld. A.P.P. appearing on behalf of State opposed the prayer of petitioners for anticipatory bail.

6. Trial Court Record (T.C.R) & Case Diary (CD) have been received. Heard, rival contentions of both the parties and perused the record. From perusal of record, it transpires that there is allegation against accused petitioners that they have forcefully cultivating the land of informant without getting any registered rent. Petitioners have submitted that they have taken the land from accused Awadhesh Gope on *Battai*. Title Suit for the land in dispute has been filed by informant and same is pending in the Court. This case relates to land dispute and same is purely civil nature.

7. Considering the aforesaid facts & circumstances, **prayer of anticipatory bail** of all above named petitioners, are *hereby allowed*. Accordingly, in the event of their arrest or surrender before the Ld. Trial Court **within four weeks from the date of receipt of the copy of this order**, petitioners are directed to be released on bail on furnishing bail bond of **Rs. 10,000/- (Ten thousand) each with two sureties** of the like amount each to the satisfaction of the Ld. Trial Court, subject to conditions as laid down *u/s* 482(2) BNSS. **Further condition that (a) One of the Bailor shall be family member/close relative, (b) They will co-operate in the investigation of this case.** Observations/findings made above is only restricted for disposal of this bail petition and it will not effect the merit of case during investigation, enquiry & trial case. Let the copy of this order be sent to the concerned Trial Court.


