ORDER

PRESENT : SRI SHAILENDRA KUMAR SINGH, ASJ-IV

1. A petition dated **23/02/2026**, for grant of anticipatory bail filed on behalf of the above named accused petitioners, who are apprehending their arrest in connection with **Pachmahla P.S Case No. 06 of 2026**, for the alleged have committed offenses punishable u/s 126(2), 115(2), 329(2), 109(1), 352, 351(2)(3) r/w 3(5) BNS, *pressed today*.

2. Heard, Ld. Counsel for the petitioners as well as Ld. Addl. Public Prosecutor (APP), appearing on behalf of the State.

3. Prosecution case, *in brief*, as per *written report* of **informant Jhagru Manjhi**, is that on 14/01/2026 at 06:00 AM, when his brother Sujit Kumar demanded money back from Badal Manjhi to whom he has given Rs. 10,000/- as loan. On which, Badal Manjhi got excited & assaulted his brother. Later on, Badal Manjhi alongwith his family member came to his house & started assaulting him and his family, due to which, they sustained injury on various part of body including head. They were referred from Barhaiya hospital to Lakhisarai for better treatment.

4. At Para- 2 & 3 of the bail petition, certificate has been given by petitioners that earlier no regular or anticipatory bail either before Ld. Court of Sessions or before Hon'ble High Court has been filed, nor any bail application is pending before any Court. Petitioners have **no** criminal antecedents. Petitioners are innocent and they have falsely been implicated in the present case. The both parties are *gotia*. The counter-case has been also registered against the informant and his family members as Pachmahala P.S. Case No. 85/2025 u/s 126(2), 115(2), 329(2), 109(1), 352, 351(2)(33) r/w 3(5) BNS. Petitioners are ready to furnish bail bond with sound sureties & obey each and every conditions imposed by Court, if bail is granted.

5. Ld. A.P.P. appearing on behalf of State vehemently opposed the prayer of petitioners for anticipatory bail and submitted that petitioners have brutally assaulted informant and his family members.

6. Trial Court Record (T.C.R.) & case diary (CD) have been received. Heard, rival contentions of both the parties and perused the record. From perusal of record, it transpires that there is **direct and specific** allegation against accused persons that they have assaulted informant and his family member with *lathi, danda*, due to which, **they sustained injury on various part of body including head**. As per injury report attached with CD, **Sudhir Manjhi & Jhagru Manjhi sustained head injuries**. Informant in his re-statement and other witnesses at different paras of case diary have supported the version of FIR. Investigation is still going on, new facts may emerge.

7. Considering the aforesaid facts and circumstances, **nature, gravity and seriousness** of accusation, this Court is not inclined to grant privilege of anticipatory bail to the all above named petitioners. *Accordingly*, prayer for anticipatory bail of petitioners are hereby ***Rejected***. Let the copy of this order be sent to the concerned Trial Court.
