ORDER

1. Bail petition dated 26/02/2026 for grant of regular bail filed on behalf of above named accused petitioner, who is in judicial custody since, 19/02/2026 in connection with Barh P.S. Case No. 666 of 2025, for the offence u/s 126(2), 115(2), 303(2), 109(1), 324(4), 352, 351(2) r/w 3(5) BNS, pressed today.

2. Heard, Ld. Counsel & Ld. Addl. Public Prosecutor (APP) appearing on behalf of the petitioner as well as the State.

3. Prosecution case, in brief, as per written report of informant Neetu Devi, is that on 29/11/2025 at 10:00 PM, when her husband Bablu Kumar reached near Kargin Chowk Bus Stand, where Satyam Kumar and others stopped her husband and assaulted with butt of pistol, due to which he sustained head injury. They also snatched bag, gold chain, ring & cash from her husband. They pulled out finger nails and demanded ransom of Rs. 50,000/-. Her husband was taken to SDH Barh from where referred to PMCH.

4. It has been submitted by the Ld. Counsel for the petitioner that earlier no regular or anticipatory bail either before Ld. Court of Sessions or before Hon'ble High Court has been filed, nor any bail application is pending before any Court and the petitioner has criminal antecedent. There is no specific allegation against the petitioner. Section 109(1) of BNS is misconceived in the FIR and Section 303(2) super-addition in this case. Petitioner is ready to furnish bail bond with sound sureties & obey each and every conditions imposed by Court, if bail is granted.

5. Learned A.P.P. appearing on behalf of State opposed the prayer for regular bail of accused petitioners.

6. Case Diary(CD) & TCR have been received. Heard, rival contentions of both the parties and perused the record. From perusal of record, it transpires that there is general & omnibus allegation against accused petitioner that he alongwith other co-accused persons have assaulted & snatched gold chain and ring & demanded ransom of Rs. 50,000/-. As per injury report attached with case diary, abrasion and bruises found in the head of Bablu Kumar. Despite giving ample opportunity, Ld. PP and Advocate for the informant failed to produce final injury report, no alleged items has been snatched recovery from the possession of petitioner. Petitioner has been under judicial custody since, 19/02/2026. Co-accused persons placed at similar footing has already been **granted regular bail vide order dated 19/01/2026 passed in BP No. 838/2025.**

7. Considering the aforesaid facts & circumstances, **period of custody & undergone** prayer of regular bail of on behalf of above named accused petitioner, **is hereby allowed.** Accordingly, the petitioner is directed to be released on bail, on furnishing bail bond of **Rs. 10,000/- (Ten thousand) each with two sureties** of the like amount each to the satisfaction of the Ld. Trial Court, subject to conditions **that (a) One of the Bailor shall be family member/close relative, (b) He will co-operate in the investigation of this case & (c) Not to commit such occurrence in future.** Let the copy of this order be sent to the concerned Trial Court.
