ORDER

1. The anticipatory bail application has been filed on the behalf of the petitioner **Pal Kumar @ Shishupal Kumar**, who is apprehending arrest in connection with **Salimpur P.S. Case No. 152 of 2025** registered **115(2), 126(2), 118(1), 109, 352, 351(2) & 3(5) of BNS**.

2. Heard the Ld. Counsel for the petitioner and the Ld. APP for the state.

3. The allegation against this petitioner that he along with his associates assaulted the informant by lathi and iron rod and thereby caused him severe head injury. Subsequently, FIR was registered.

4. The Ld. Counsel for the petitioner submit that the petitioner is innocent and has falsely been implicated. It is further submitted that there is no specific allegation of carrying out attack on the informant. So, Sec. 109(1) of the BNS is not made out against this petitioner. Hence, prays for enlarging the petitioner on bail.

5. The Ld. APP vehemently opposed the prayer of bail.

6. Heard both the sides and perused the case record . From the perusal of record, it transpires that the informant initially got treated in the primary health center, Bakhtiyarpur from where he was referred to the higher center for a treatment after reserving the opinion in want of C.T. Scan report. It further transpires from the report as prepared by the P.M.C.H, Patna that the informant received skin deep injury on the right side of eyebrow i.e. vital part of the body. Further, this petitioner has two criminal antecedents as informed by the counsel for the petitioner by way of filing a supplementary before this court during the course of hearing.
