ORDER

1. A petition dated **23/05/2026**, for grant of anticipatory bail filed on behalf of above named **sole** petitioner, who is apprehending his arrest in connection with **Salimpur P.S Case No. 343 of 2025**, for the alleged have committed offenses punishable u/s 127(1), 115(2), 109, 303(2), r/w 3(5) BNS, *pressed today*.

2. Heard, Ld. Counsel for the petitioner as well as Ld. Addl. Public Prosecutor (APP), appearing on behalf of the State.

3. Prosecution case, *in brief*, as per written report of informant **Radhe Kumar** in brief, is that on 29/11/2025 at 03:30 PM, Karika @ Dablu alongwith 04-05 other unknown person stopped him and asked to play *Yadav song on DJ*. On refusal, they assaulted him & his brother Pintu, Jitendra and Cameraman, due to which, they sustained head injury. They snatched *Mangalsutra* of his sister and fled away firing bullets.

4. At Para- 2 & 3 of the bail petition, certificate has been given by petitioner that earlier no regular or anticipatory bail either before Ld. Court of Sessions or before Hon'ble High Court has been filed, nor any bail application is pending before any Court and he **has criminal antecedent**. Petitioner is innocent and has falsely been implicated in the present case. Petitioner is not named in FIR. The confessional statement recorded by police is not admissible in the eye of law. Petitioner is ready to furnish bail bond with sound sureties & obey each and every conditions imposed by Court, if bail is granted.

5. Ld. A.P.P. appearing on behalf of State vehemently opposed the prayer of petitioner for anticipatory bail and submitted that he alongwith other co-accused assaulted to informant and his brothers, due to which, they sustained head injury.

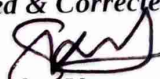

6. Trial Court Record (T.C.R.) & case diary (CD) have been received. Heard, rival contentions of both the parties and perused the record. From perusal of record, it transpires that there is **direct & specific** allegation against accused petitioner that he alongwith other co-accused assaulted to informant & his brothers & cameraman with *lathi & butt of pistol*, due to which, they **sustained head injury**. As per injury report attached with CD, Jitendra Kumar, Pintu Kumar & Radhe Shyam Kumar sustained injury **on their head which is vital part of the body**. Informant in his re-statement and other witnesses at different paras of case diary **have supported the version of FIR**. Investigation is still going on, new facts may emerge. Petitioner has criminal antecedent.

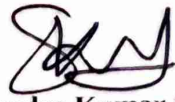
7. Considering the aforesaid facts and circumstances, **nature, gravity, criminal antecedent and seriousness of accusation**, this Court is not inclined to grant privilege of anticipatory bail to the petitioner. Accordingly, prayer for anticipatory bail on behalf of above named of **sole** petitioner is hereby **Rejected**. Observations/findings made above is only restricted for disposal of this bail petition and it will not effect the merit of case during investigation, enquiry & trial case. Let the copy of this order be sent to the concerned Trial Court.
