ORDER

1. Bail petition dated **27/06/2026** for grant of regular bail filed on behalf of above named accused petitioner, who is in judicial custody **since, 08/06/2026** in connection with **NTPC P.S. Case No. 40 of 2026**, for the offence *u/s 118(2), 109 r/w 3(5) BNS*, *pressed today*.

2. Heard, Ld. Counsel & Ld. Addl. Public Prosecutor (APP) appearing on behalf of the petitioner as well as the State.

3. Prosecution case, *in brief*, as per written report of informant **Rajnish Kumar**, is that 06/07/2026, his mother & wife have altercation, which he resolved & went for duty. At 07:00 PM, when he returned home from duty, Manjesh Kumar, Sumit Kumar & Shivam Kumar assaulted him with *iron-rod*, due to which, he sustained head injury. He was taken to SDH Barh for treatment by his elder brother Bablu Kumar.

4. It has been submitted by the Ld. Counsel for the petitioner that earlier no regular or anticipatory bail either before Ld. Court of Sessions or before Hon'ble High Court has been filed, nor any bail application is pending before any Court and the petitioner has **no** criminal antecedent. There is no any specific allegation of any overt-act against the petitioner. No case make out *u/s 118(2), 109 of BNS* against the petitioner. Petitioner is ready to furnish bail bond with sound sureties & obey each and every conditions imposed by Court, if bail is granted.

5. Learned A.P.P. appearing on behalf of State opposed the prayer for regular bail of accused petitioner and conceded the fact both parties are own brother.

6. Trial Court Record (T.C.R) & Case Diary (CD) have been received. Heard, rival contentions of both the parties and perused the record. From perusal of record, it transpires that there is allegation against petitioner that he alongwith other co-accused persons have assaulted informant with *iron-rod*, due to which, he sustained injury in head. As per injury report attached with CD, **injury of petitioner is simple in nature**. Petitioner has been under judicial custody since, 08/06/2026. **Petitioner & informant are own brothers**. As per para-22 of CD, petitioner has **no criminal antecedents**.

7. Considering the aforesaid facts & circumstances **period of custody undergone & clean antecedent** prayer of regular bail of on behalf of above named accused petitioner, **is hereby allowed**. Accordingly, the petitioner is directed to be released on bail, on furnishing bail bond of **Rs. 10,000/- (Ten thousand) each with two sureties** of the like amount each to the satisfaction of the Ld. Trial Court, subject to conditions **that (a) He will co-operate in the investigation of this case, (b) One of the Bailor shall be family member/close relative & (c) Not to commit such type of occurrence in future**. It is, however, clarified that the observations made herein are limited to the adjudication of the present bail application and shall not prejudice the case of the petitioner at any subsequent stage of the investigation/trial and this Court has not expressed any opinion on the merits of the case.
