Regular Bail Petition has been filed on the behalf of Accused Applicant Arati Devi who is in custody since 28.03.2026 along with fresh power by Ld. Counsel for the petitioner Shri Lallu Prasad. Copy of the petition is served on Ld. APP for the state.

The above name accused petitioner is named in Masaurhi(Lahsuna) P.S Case No:- 219/2026 for offenses U/S 103(1), 61(2), 3(5) of BNS. The case of prosecution in brief is that informant Sanju Devi states that on 26.03.2026 at about 11:00 PM, her son Ajeet Kumar inform her on mobile that Sonu Kumar took him along. Due to previous enmity they beat him and left him near Village Bishbiga Ushmanchak. Then, her younger son Vimal Kumar went and saw that her brother was fallen down. He took him to Sub divisional hospital Masaurhi for treatment where his brother was declared dead by the doctor. As per the infomant Aarti Devi, Sonu Kumar, Sangeeta Devi, Sanjay Yadav have beaten her son and killed him under conspiracy by feeding him poisonous substance.

Ld. Counsel for the Petitioners submits that the applicants have not previously filed any anticipatory or regular bail application before any court. The applicant has no criminal cases against him. It is submitted that the applicants are innocent and has not committed any crime as alleged in the prosecution case. There is no chance of absconding of the petitioner or tampering with evidence. Petitioner's husband was murdered under conspiracy. She had no dispute with her husband. There was some dispute for partition. The alleged sections are not attracted against the petitioner. On the other hand Ld. APP for the state has opposed the prayer the bail.

Heard both sides. Case Diary has been called for and is received. Perused case diary and case record. As per the case of prosecution co-accused Sonu Kumar called the deceased Ajeet Kumar and accused persons of the case have beaten Ajeet Kumar and killed him under conspiracy by feeding poisonous substance. The witnesses in the case diary para 2 , 8 and 9 have supported the case of prosecution. There is allegation of giving poisonous substance to

the deceased. FSL report of Viscera is received and also the final post-mortem report is available. The final post-mortem report discloses that cause of death of the deceased is acute cardiogenic shock consequent upon consumption of aluminum phosphide poison. Investigation against the petitioner is concluded and after finding the case true against her chargesheet is submitted.

Considering the above facts, circumstances, and allegation of involvement in serious nature of the case this court is not inclined to enlarge the accused petitioner Arati Devi on Regular bail. Therefore, the prayer of bail of the above named accused petitioner Arati Devi is rejected. The Regular bail petition of the above named accused is dismissed.
